CHAPTER 490

3 FOR the purpose of providing the award amount for the Maryland Teacher

6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 7 MARYLAND, That the Laws of Maryland read as follows:

10 (a) [Except for an economic development student assistance grant awarded
 11 under § 18-701 of this title, a Distinguished Scholar Award under § 18-1101 of this
 12 title, and a Maryland Science and Technology Scholarship awarded under § 18-2001
 13 of this title, the] THE recipient of an Educational Excellence Award may not hold any
 14 other scholarship awarded under this title EXCEPT FOR:

15 (1) AN ECONOMIC DEVELOPMENT STUDENT ASSISTANCE GRANT
 16 AWARDED UNDER § 18-701 OF THIS TITLE;

17 (2) A DISTINGUISHED SCHOLAR AWARDED UNDER § 18-1101 OF THIS
 18 TITLE;

19 (3) A MARYLAND SCIENCE AND TECHNOLOGY SCHOLARSHIP AWARDED
 20 UNDER § 18-2001 OF THIS TITLE; ~~AND~~

21 (4) A MARYLAND TEACHER SCHOLARSHIP AWARDED UNDER § 18-2202 OF

23 (5) A MARYLAND HOPE SCHOLARSHIP AWARDED UNDER § 18-2302 OF

26 There is a program of Maryland teacher scholarships that are awarded under
 27 this subtitle for students who pledge to work as public elementary and secondary
 28 school teachers in this State upon completion of their studies.

30 The annual scholarship award shall be in the amount of [\$1,000] \$2,000 for a
 31 student enrolled at a 2-year eligible institution or [\$3,000] \$5,000 for a student
 32 enrolled in a 4-year eligible institution.

5 Maryland teacher scholarship may not hold any other scholarship awarded under this
6 title.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
8 October 1, 2000.
