CHAPTER 495

1 AN ACT concerning

2 **Procurement - Minority Business Enterprise Participation**

3 FOR the purpose of ~~increasing the minimum percentage of the total dollar value of~~
4 ~~procurement contracts made directly or indirectly from minority businesses that~~
5 ~~a unit of State government is to try to achieve; decreasing the amount of a~~
6 ~~Maryland Department of Transportation construction contract that is~~
7 ~~negotiated competitively and not subject to provisions of law regarding minority~~
8 ~~business enterprise goals *modifying the threshold governing the application of*~~
9 ~~*the State's minority business enterprise program to Maryland Department of*~~
10 ~~*Transportation construction contracts*; requiring a unit of State government to~~
11 ~~try to ensure that a certain percentage of a certain minority business enterprise~~

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 20 MARYLAND, That the Laws of Maryland read as follows:

34 (a) (1) Except for leases of real property and except as provided in
 35 paragraphs (2) and (3) of this subsection, each unit shall structure procurement
 36 procedures, consistent with the purposes of this subtitle, to try to achieve the result
 37 that a minimum of {14%} ~~30%~~ of the unit's total dollar value of procurement contracts

1 is made directly or indirectly from certified minority business enterprises IN
2 ACCORDANCE WITH THIS SECTION.

3 (2) Except as provided in paragraph (3) of this subsection, in
4 procurement for construction, each unit shall:

5 (i) structure procurement procedures, consistent with the purposes
6 of this subtitle, to try to achieve the result that a minimum of ~~{14%}~~ 30% of the unit's
7 total dollar value of construction contracts is made directly or indirectly from certified
8 minority business enterprises; and

9 (ii) consider the practical severability of the construction projects.

10 (3) With respect to the Maryland Department of Transportation, the
11 provisions of paragraph (2)(i) of this subsection shall apply only to construction
12 contracts in excess of [\$100,000] \$50,000.

13 (4) To achieve the result specified in paragraph (1) or (2) of this
14 subsection, a contractor shall:

15 (i) identify specific work categories appropriate for subcontracting;

16 (ii) at least 10 days before bid opening, solicit minority business
17 enterprises, through written notice that:

18 1. describes the categories of work under item (i) of this
19 subparagraph; and

20 2. provides information regarding the type of work being
21 solicited and specific instructions on how to submit a bid;

22 (iii) attempt to make personal contact with the firms in item (ii) of
23 this paragraph;

24 (iv) assist minority business enterprises to fulfill bonding
25 requirements or to obtain a waiver of those requirements;

26 (v) in order to publicize contracting opportunities to minority
27 business enterprises, attend prebid meetings or other meetings scheduled by the unit;
28 and

29 (vi) upon acceptance of a bid, provide the unit with a list of minority
30 businesses with whom the contractor negotiated, including price quotes from
31 minority and nonminority firms.

32 (5) (i) The unit shall make a finding whether the contractor complied,
33 in good faith, with paragraph (4) of this subsection.

34 (ii) If the unit finds the contractor complied with paragraph (4) of
35 this subsection, the unit may not require the contractor to renegotiate any
36 subcontract in order to achieve a different result.

 34 report required under § 14-305 of this subtitle.

36 The provisions of §§ 14-301 through 14-305 of this subtitle, and any regulations
 37 adopted under those sections, shall be of no effect ~~AFTER JULY 1, 2002~~ 2001 and may

2 SECTION 2. AND BE IT FURTHER ENACTED, That the Certification Agency,
3 in consultation with the General Assembly AND THE OFFICE OF THE ATTORNEY
4 GENERAL, shall initiate a study of the Minority Business Enterprise Program to
5 evaluate the Program's continued compliance with the requirements of the Croson
6 decision and any subsequent federal or constitutional requirements. The study shall
7 also evaluate race neutral programs and other methods that can be used to address
8 the needs of minority businesses. ~~An executive summary of the study shall be~~
9 ~~submitted to the Legislative Policy Committee of the General Assembly by December~~
10 ~~1, 2000. AN EXECUTIVE SUMMARY OF THE STUDY SHALL BE SUBMITTED TO THE~~
11 ~~LEGISLATIVE POLICY COMMITTEE OF THE GENERAL ASSEMBLY BY DECEMBER 1,~~
12 ~~2000.~~ The final report on the study shall be submitted to the Legislative Policy
13 Committee of the General Assembly prior to ~~September 30, [1999] 2000 January 3~~
14 ~~JANUARY 10, 2001~~ so that the General Assembly may review the report ~~prior to~~
15 DURING the [2000] 2001 Session.
