CHAPTER 50

1 AN ACT concerning

2 **Tax - Property - Prince George's County - Property Tax Credit**

3 FOR the purpose of altering a provision of law authorizing the governing body of
4 Prince George's County to grant a property tax credit against the county
5 property tax or special district tax for certain property to include property
6 owned by the Lake Arbor Foundation, Inc.; and generally relating to the
7 authority of the governing body of Prince George's County to grant a certain
8 property tax credit for certain property.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article - Tax - Property**

17 9-318.

18 (c) The governing body of Prince George's County may grant, by law, a
19 property tax credit under this section against the county property tax or special
20 district tax imposed on:

21 (1) property that is owned by the Chapel Hill Citizens' Association;

- 1 (2) property that is:
- 2 (i) owned by the Clinton Boys and Girls Club; and
- 3 (ii) used only for nonprofit athletic recreation;
- 4 (3) property that is owned by the East Pines Citizens' Association;
- 5 (4) property that is owned by the Lions Club of Bowie;
- 6 (5) property that is owned by the Prince George's Jaycees, Incorporated;
- 7 (6) property that is owned by the Suitland Civic Association,
8 Incorporated;
- 9 (7) real property that is:
- 10 (i) owned by the Prince George's County Parks and Recreation
11 Foundation; and
- 12 (ii) is not used for a commercial purpose;
- 13 (8) property that is:
- 14 (i) owned by the Freestate Riding Club, Inc.; and
- 15 (ii) used only for nonprofit athletic recreation; [and]
- 16 (9) property that is owned by a boys and girls club in Prince George's
17 County that is chartered by the Prince George's County Boys and Girls Club,
18 Incorporated; AND
- 19 (10) PROPERTY THAT IS OWNED BY THE LAKE ARBOR FOUNDATION,
20 INCORPORATED.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
22 ~~October 1, 2000~~ July 1, 2000.
