CHAPTER 537

1 AN ACT concerning

2 **Education - Maryland Dent-Care Program**

3 FOR the purpose of establishing the Maryland Dent-Care Program to provide certain
4 education loan assistance grants to certain dentists who agree that a certain
5 percentage of their patients treated for a certain period of time will be Maryland
6 Medical Assistance Program recipients; requiring the State Scholarship
7 Administration to administer the Maryland Dent-Care Program with the
8 assistance of the Department of Health and Mental Hygiene, Office of Oral
9 Health; establishing certain requirements for receiving a grant under the
10 Program; authorizing the Administration to award a certain number of grants
11 per year to a certain maximum number of participants in the Program;
12 authorizing a certain maximum amount for each grant; establishing certain
13 requirements for participants in the Program to continue to receive grants;
14 requiring the Administration, in collaboration with the Department of Health
15 and Mental Hygiene, to adopt certain regulations; providing for funding for the
16 Program as provided in the State budget; defining certain terms; and generally
17 relating to the Maryland Dent-Care Program.

2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
3 MARYLAND, That the Laws of Maryland read as follows:

4 **Article - Education**

5 SUBTITLE 24. MARYLAND DENT-CARE PROGRAM.

6 18-2401.

7 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
8 INDICATED.

9 (B) "HIGHER EDUCATION LOAN" MEANS ANY LOAN FOR UNDERGRADUATE OR
10 GRADUATE STUDY LEADING TO PRACTICE AS A DENTIST THAT IS OBTAINED FOR
11 TUITION, EDUCATIONAL EXPENSES, OR LIVING EXPENSES FROM:

12 (1) A COLLEGE OR UNIVERSITY, GOVERNMENT, OR COMMERCIAL
13 SOURCE; OR

14 (2) AN ORGANIZATION, INSTITUTION, ASSOCIATION, SOCIETY, OR
15 CORPORATION THAT IS EXEMPT FROM TAXATION UNDER § 501(C)(3) OR (4) OF THE
16 INTERNAL REVENUE CODE OF 1986.

17 (C) "PROGRAM" MEANS THE MARYLAND DENT-CARE PROGRAM.

18 18-2402.

19 (A) THERE IS A PROGRAM OF HIGHER EDUCATION LOAN ASSISTANCE GRANTS
20 TO DENTISTS IN THE STATE, KNOWN AS THE MARYLAND DENT-CARE PROGRAM.

21 (B) THE PURPOSE OF THE PROGRAM IS TO INCREASE ACCESS TO ORAL
22 HEALTH SERVICES FOR UNDERSERVED MARYLAND MEDICAL ASSISTANCE PROGRAM
23 RECIPIENTS BY INCREASING THE NUMBER OF DENTISTS WHO TREAT THAT
24 POPULATION.

25 18-2403.

26 (A) THE ADMINISTRATION SHALL ADMINISTER THE PROGRAM WITH THE
27 ASSISTANCE OF THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE, OFFICE OF
28 ORAL HEALTH.

29 (B) THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE, OFFICE OF ORAL
30 HEALTH SHALL:

31 (1) RECRUIT DENTISTS TO PARTICIPATE IN THE PROGRAM;

32 (2) DETERMINE IF THE PRIVATE PRACTICE OR CLINICAL SETTING IN
33 WHICH AN APPLICANT WILL PRACTICE IS LOCATED NEAR OR READILY ACCESSIBLE

1 TO UNDERSERVED MARYLAND MEDICAL ASSISTANCE PROGRAM RECIPIENTS AND IF
2 THE APPLICANT QUALIFIES FOR THE PROGRAM;

3 (3) DETERMINE IF EACH PARTICIPANT MEETS THE PROGRAM
4 REQUIREMENTS AND SERVES THE REQUIRED NUMBER OF MARYLAND MEDICAL
5 ASSISTANCE PROGRAM RECIPIENTS; AND

6 (4) NOTIFY THE ADMINISTRATION OF ANY FINDINGS MADE IN
7 ACCORDANCE WITH THE PROVISIONS OF THIS SUBSECTION.

8 18-2404.

9 EACH APPLICANT FOR A HIGHER EDUCATION LOAN ASSISTANCE GRANT UNDER
10 THIS SUBTITLE SHALL:

11 (1) BE LICENSED TO PRACTICE IN MARYLAND BY THE STATE BOARD OF
12 DENTAL EXAMINERS;

13 (2) DEMONSTRATE FINANCIAL NEED;

14 (3) BE EMPLOYED FULL TIME AS A DENTIST;

15 (4) AGREE THAT AT LEAST 30% OF THE PATIENTS TREATED BY THE
16 DENTIST EACH YEAR FOR A 3-YEAR PERIOD IN A PRIVATE PRACTICE OR CLINICAL
17 SETTING WILL BE MARYLAND MEDICAL ASSISTANCE PROGRAM RECIPIENTS; AND

18 (5) MEET ANY OTHER CRITERIA ESTABLISHED BY THE
19 ADMINISTRATION.

20 18-2405.

21 (A) THE ADMINISTRATION, ON NOTIFICATION BY THE DEPARTMENT OF
22 HEALTH AND MENTAL HYGIENE, MAY AWARD HIGHER EDUCATION LOAN
23 ASSISTANCE GRANTS TO UP TO 5 PARTICIPANTS EACH YEAR, WITH A MAXIMUM OF 15
24 PARTICIPANTS IN THE PROGRAM.

25 (B) A HIGHER EDUCATION LOAN ASSISTANCE GRANT UNDER THIS SUBTITLE
26 MAY BE IN THE AMOUNT OF UP TO \$33,000 PER YEAR.

27 18-2406.

28 EACH RECIPIENT OF A HIGHER EDUCATION LOAN ASSISTANCE GRANT UNDER
29 THIS SUBTITLE MAY HOLD THE GRANT FOR UP TO 3 YEARS IF THE RECIPIENT:

30 (1) CONTINUES TO BE EMPLOYED FULL TIME AS A DENTIST; AND

31 (2) CONTINUES TO TREAT MARYLAND MEDICAL ASSISTANCE PROGRAM
32 RECIPIENTS AS AT LEAST 30% OF ALL PATIENTS TREATED BY THE DENTIST IN A
33 PRIVATE PRACTICE OR CLINICAL SETTING AUTHORIZED UNDER THE PROGRAM.

2 THE ADMINISTRATION, IN COLLABORATION WITH THE DEPARTMENT OF
3 HEALTH AND MENTAL HYGIENE, SHALL ADOPT REGULATIONS TO CARRY OUT THE
4 PROVISIONS OF THIS SUBTITLE, INCLUDING REGULATIONS ON REPAYMENT OF
5 FUNDS IF THE PARTICIPANT FAILS TO COMPLY WITH THE REQUIREMENTS OF THE
6 PROGRAM.

7 18-2408.

8 FUNDS FOR THE PROGRAM SHALL BE AS PROVIDED IN THE STATE BUDGET.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
10 June 1, 2000.
