6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
 7 MARYLAND, That the Laws of Maryland read as follows:

23 (9-1) "HARD CIDER" MEANS A BEVERAGE DERIVED PRIMARILY FROM  
 24 APPLES OR APPLE CONCENTRATE AND WATER, CONTAINING NO OTHER FRUIT  
 25 PRODUCT, AND CONTAINING AT LEAST ONE-HALF OF 1% AND LESS THAN 7% OF  
 26 ALCOHOL BY VOLUME.

8 (3) FOR THE PURPOSES OF THIS TITLE, HARD CIDER, AS DEFINED IN  
9 ARTICLE 2B, § 1-102(A)(9-1) OF THE CODE, SHALL BE CONSIDERED AS BEER IN ALL  
10 RESPECTS.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
12 October 1, 2000.
