AMENDMENTS TO HOUSE BILL NO. 518

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with “any” in line 3 down through “dispute” in line 4 and substitute “specific controversies or disputes”; strike beginning with “, subject” in line 6 down through “governments” in line 7; in lines 5, 7, and 13, in each instance, strike “Board” and substitute “State Labor Relations Board”; strike beginning with “authorizing” in line 9 down through “Act” in line 12 and substitute “exempting certain matters pertaining to students from negotiations; requiring the State Board of Education to make certain determinations on petition by either party; prohibiting certain matters pertaining to students from being petitioned by either party to the State Board of Education for determination”; in line 14, strike “Board order” and substitute “State Labor Relations Board order”; in the same line, strike “the Board” and substitute “the State Labor Relations Board”; and strike beginning with “the authority” in line 21 down through “employees” in line 23 and substitute “negotiations and the resolution of certain controversies and disputes involving school personnel”.

AMENDMENT NO. 2

On page 2, in line 33, strike “TITLE 6, SUBTITLE 4 OR SUBTITLE 5” and substitute “§ 6-405 OR § 6-506”.

On page 3, strike beginning with the comma in line 1 down through “JURISDICTION” in line 4.

AMENDMENT NO. 3

On page 5, in lines 17, 18, and 32, in each instance, strike “LABOR RELATIONS”; in line 19, strike “MANDATORY SUBJECT, A”; and in the same line strike “, OR AN ILLEGAL SUBJECT”.

On page 5, in line 28, strike the brackets; and in lines 28 and 29, strike “LABOR

RELATIONS BOARD”.

On page 6, in line 3, strike “LABOR RELATIONS”.

On page 9, in lines 7, 8, 18, and 25, in each instance, strike “LABOR RELATIONS”.

On page 9, in line 14, strike the brackets; and in lines 14 and 15, strike “LABOR RELATIONS BOARD”.

AMENDMENT NO. 4

On page 5, in line 16, after “ORGANIZATION” insert “, BUT MAY NOT INCLUDE MATTERS PERTAINING EXCLUSIVELY TO:

1. STUDENT CLASS SIZE;
2. STUDENT CALENDAR;
3. STUDENT SCHOOL DAY; AND
4. STUDENT PLACEMENT”.

AMENDMENT NO. 5

On page 5, in line 17, after “(2)” insert “(I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS PARAGRAPH,”; and after line 20, insert:

“(II) EITHER PARTY IS PROHIBITED FROM PETITIONING THE STATE BOARD ON MATTERS PERTAINING EXCLUSIVELY TO:

1. STUDENT CLASS SIZE;
2. STUDENT CALENDAR;
3. STUDENT SCHOOL DAY; AND
4. STUDENT PLACEMENT.”.

AMENDMENT NO. 6

On page 9, in line 6, after “ORGANIZATION” insert “, BUT MAY NOT INCLUDE MATTERS PERTAINING EXCLUSIVELY TO:

1. STUDENT CLASS SIZE;
2. STUDENT CALENDAR;
3. STUDENT SCHOOL DAY; AND
4. STUDENT PLACEMENT”.

AMENDMENT NO. 7

On page 9, in line 7, after “(2)” insert “(I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS PARAGRAPH,”; in line 9, strike “MANDATORY SUBJECT, A”; in the same line, strike “, OR AN ILLEGAL SUBJECT”; and after line 10, insert:

“(II) EITHER PARTY IS PROHIBITED FROM PETITIONING THE STATE BOARD ON MATTERS PERTAINING EXCLUSIVELY TO:

1. STUDENT CLASS SIZE;
2. STUDENT CALENDAR;
3. STUDENT SCHOOL DAY; AND
4. STUDENT PLACEMENT.”.
