CHAPTER 205

1 AN ACT concerning

2 **Public Service Commission - Civil Penalties**

3 FOR the purpose of authorizing the Public Service Commission to impose a civil
4 penalty for violations of the Public Utility Companies Article or certain rules,
5 orders, or directives of the Commission.

6 BY adding to

7 Article - Public Utility Companies

8 Section 13-201.1

9 Annotated Code of Maryland

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Article - Public Utility Companies**

14 13-201.1.

15 (A) THIS SECTION DOES NOT APPLY TO:

16 (1) A COMMON CARRIER; OR

17 (2) A VIOLATION OF THE FOLLOWING PROVISIONS OF THIS ARTICLE:

18 (I) TITLE 5, SUBTITLE 4;

- 1 (II) TITLE 7, SUBTITLE 1;
2 (III) TITLE 8, SUBTITLES 1 AND 3;
3 (IV) TITLE 9, SUBTITLE 3; AND
4 (V) TITLE 8, SUBTITLE 4.

5 (B) THE COMMISSION MAY IMPOSE A CIVIL PENALTY NOT EXCEEDING \$10,000
6 AGAINST A PERSON WHO VIOLATES A PROVISION OF THIS ARTICLE, OR AN
7 EFFECTIVE AND OUTSTANDING DIRECTION, RULING, ORDER, RULE, OR REGULATION
8 OF THE COMMISSION.

9 (C) (1) A CIVIL PENALTY MAY BE IMPOSED IN ADDITION TO ANY OTHER
10 PENALTY AUTHORIZED BY THIS ARTICLE.

11 (2) EACH VIOLATION IS A SEPARATE OFFENSE.

12 (3) EACH DAY OR PART OF A DAY THE VIOLATION CONTINUES IS A
13 SEPARATE OFFENSE.

14 (D) THE COMMISSION SHALL DETERMINE THE AMOUNT OF ANY CIVIL
15 PENALTY AFTER CONSIDERING:

16 (1) THE NUMBER OF PREVIOUS VIOLATIONS OF ANY PROVISION OF THIS
17 ARTICLE;

18 (2) THE GRAVITY OF THE CURRENT VIOLATION;

19 (3) THE GOOD FAITH EFFORTS OF THE VIOLATOR IN ATTEMPTING TO
20 ACHIEVE COMPLIANCE AFTER NOTIFICATION OF THE VIOLATION; AND

21 (4) ANY OTHER MATTER THAT THE COMMISSION CONSIDERS
22 APPROPRIATE AND RELEVANT.

23 (E) A CIVIL PENALTY COLLECTED UNDER THIS SECTION SHALL BE PAID INTO
24 THE GENERAL FUND OF THE STATE.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
26 effect October 1, 2001.
