CHAPTER 427

1 AN ACT concerning

2 **Nursing Staff Agencies - Quality Oversight and Improvement**

3 FOR the purpose of transferring oversight of nursing staff agencies from the Board of
4 Nursing to the Office of Health Care Quality; requiring nursing staff agencies to
5 ~~register with~~ be licensed by the Office; providing for the procedures and
6 requirements for licensing nursing staff agencies ~~registering with~~ by the Office;
7 requiring nursing staff agencies to submit certain information to the Office;
8 ~~requiring the Office to conduct periodic site visits and surveys of nursing staff~~
9 ~~agencies; requiring the Office to investigate certain factors during the survey;~~
10 ~~requiring the Office to maintain a report of each survey; authorizing the Office~~
11 ~~to adopt certain regulations and conduct certain inspections; requiring a nursing~~
12 ~~staff agency to perform certain personnel duties and verify certain conditions;~~
13 ~~providing for certain penalties for certain nursing staff agencies; providing~~
14 ~~certain penalties for certain violations; requiring a nursing staff agency to attest~~
15 ~~to compliance with certain federal laws; requiring that fines collected by the~~

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 27 MARYLAND, That Section(s) 8-507 of Article - Health Occupations of the Annotated
 28 Code of Maryland be transferred to be Section(s) 19-2001 of Article - Health -
 29 General of the Annotated Code of Maryland.

33 **SUBTITLE 20. NURSING STAFF AGENCIES.**

35 (a) (1) In this [section] SUBTITLE the following words have the meanings
 36 indicated.

1 (2) "CLIENT FACILITY" MEANS A HEALTH CARE FACILITY THAT
 2 CONTRACTS WITH A NURSING STAFF AGENCY FOR THE REFERRAL OF NURSING
 3 PERSONNEL.

4 [(2)] (3) "Health care facility" means a hospital or related institution as
 5 defined in § 19-301 of [the Health - General Article] THIS ARTICLE.

6 [(3)] (4) "Initially providing or referring" means the first time a nursing
 7 staff agency provides or refers a particular licensed practical nurse, registered nurse,
 8 or [geriatric] CERTIFIED nursing assistant to a health care facility.

9 [(4)] (5) "Nursing personnel" means:

10 (i) Any individual licensed by the State Board of Nursing as a:

11 1. Licensed practical nurse; or

12 2. Registered nurse; or

13 (ii) A [geriatric] CERTIFIED nursing assistant [who complies with
 14 the provisions of § 19-308.1 of the Health - General Article for patient care
 15 personnel].

16 [(5)] (6) (i) "Nursing staff agency" means any person, firm,
 17 corporation, partnership, or other business entity engaged in the business of
 18 ~~providing or referring nursing personnel~~ AS EMPLOYEES OR INDEPENDENT
 19 CONTRACTORS to render temporary nursing services at a health care facility in the
 20 State.

21 (ii) "Nursing staff agency" does not include:

22 [1. Any person, firm, corporation, partnership, or other
 23 business entity engaged solely in the business of providing or referring nursing
 24 personnel to render private duty nursing care at a health care facility;

25 2.] 1. A nursing staff agency operated by a health care
 26 facility solely for the purpose of procuring, furnishing, or referring temporary or
 27 permanent nursing personnel for employment at that health care facility;

28 [3.] 2. A home health agency regulated under Title 19,
 29 Subtitle 4 of [the Health - General Article] THIS ARTICLE; or

30 [4.] 3. Any nursing personnel procuring, furnishing, or
 31 referring their own services to a health care facility without the direct or indirect
 32 assistance of a nursing staff agency.

33 (7) "OFFICE" MEANS THE OFFICE OF HEALTH CARE QUALITY IN THE
 34 DEPARTMENT.

35 [(6)] (8) "Responsible party" means the individual at a nursing staff
 36 agency who controls the day to day operation of the nursing staff agency.

1 (b) (1) A NURSING STAFF AGENCY SHALL BE LICENSED BY THE OFFICE
 2 BEFORE REFERRING NURSING PERSONNEL TO A HEALTH CARE FACILITY TO RENDER
 3 TEMPORARY NURSING SERVICES AT A HEALTH CARE FACILITY IN THIS STATE.

4 (2) All nursing staff agencies shall submit to the [Board] OFFICE, ~~the~~:

5 (I) THE nursing staff agency's:

6 (1) 1. Business name;

7 (2) 2. Business address;

8 (3) 3. Business telephone number; and

9 (4) 4. Responsible party; AND

10 (II) ANY OTHER INFORMATION THE OFFICE REQUIRES BY
 11 REGULATION TO ASSURE ENSURE COMPLIANCE WITH THE PROVISIONS OF THIS
 12 SUBTITLE.

13 (c) (1) A nursing staff agency ~~registration~~ LICENSE expires on the 28th day
 14 of the month in which the agency was originally ~~registered~~ LICENSED unless the
 15 license is renewed for a 1-year term as provided in this section.

16 (2) At least 1 month before the ~~registration~~ LICENSE expires, the
 17 [Board] OFFICE shall send to the nursing staff agency, by first-class mail to the last
 18 known address of the nursing staff agency, a renewal notice that states:

19 (i) The date on which the current ~~registration~~ LICENSE expires;

20 (ii) The date by which the renewal application must be received by
 21 the [Board] OFFICE for the renewal to be issued and mailed before the ~~registration~~
 22 LICENSE expires; and

23 (iii) The amount of the renewal fee.

24 (3) Before a ~~registration~~ LICENSE expires, the nursing staff agency
 25 periodically may renew it for an additional term, if the nursing staff agency:

26 (i) Otherwise is entitled to be ~~registered~~ LICENSED; and

27 (ii) Pays to the [Board] OFFICE the renewal fee set by the [Board]
 28 OFFICE.

29 (d) If a nursing staff agency fails to renew, the nursing staff agency must
 30 immediately stop referring personnel to health care facilities.

31 (e) (1) A nursing staff agency shall notify the [Board] OFFICE of any change
 32 in ownership, agency name, or address within 30 days of the change.

1 (2) Notwithstanding the provisions of subsection ~~(j)(4)~~ (I)(1) of this
 2 section, if a nursing staff agency fails to notify the [Board] OFFICE within the time
 3 required under this subsection, the [Board] OFFICE may impose a fine of \$100.

4 (f) (1) Before initially providing or referring a licensed practical nurse ~~or,~~
 5 registered nurse, OR CERTIFIED NURSING ASSISTANT to health care facilities to
 6 render temporary nursing services the nursing staff agency shall:

7 ~~(i) Submit the name and license number of the licensed practical~~
 8 ~~nurse or registered nurse to the [Board] OFFICE; and~~

9 ~~(ii) Verify~~ VERIFY the licensure status of the licensed practical
 10 nurse ~~or,~~ registered nurse, OR CERTIFIED NURSING ASSISTANT.

11 (2) At the time a licensed practical nurse ~~or,~~ registered nurse, OR
 12 CERTIFIED NURSING ASSISTANT who is being referred to health care facilities by a
 13 nursing staff agency must renew their license to practice licensed practical nursing
 14 ~~or,~~ registered nursing, OR CERTIFIED NURSING ASSISTANT ASSISTANCE, the nursing
 15 staff agency shall:

16 (i) Submit the name and license number of the licensed practical
 17 nurse ~~or,~~ registered nurse, OR CERTIFIED NURSING ASSISTANT to the [Board]
 18 OFFICE; and

19 (ii) Verify the licensure status of the licensed practical nurse ~~or,~~
 20 registered nurse, OR CERTIFIED NURSING ASSISTANT.

21 [(3) (i) On the request of a nursing staff agency, the Board shall verify
 22 by telephone or other electronic means the licensure status of any licensed practical
 23 nurse or registered nurse that the nursing staff agency plans to refer to health care
 24 facilities within 24 hours of the request.

25 (ii) The Board shall provide written confirmation of the information
 26 provided in accordance with the provisions of item (i) of this paragraph to the nursing
 27 staff agency within 10 working days of the request.

28 (4) (i) At least quarterly, the Board shall report by telephone or other
 29 electronic means to a nursing staff agency any disciplinary action taken against a
 30 licensed practical nurse or registered nurse who is being referred to health care
 31 facilities by that nursing staff agency within the previous quarter.

32 (ii) The Board shall provide written confirmation of the information
 33 provided in accordance with the provisions of item (i) of this paragraph to the nursing
 34 staff agency within 10 working days of the disciplinary action being taken.

35 (g) Before initially providing or referring a geriatric nursing assistant to
 36 related institutions to render temporary services, the nursing staff agency shall verify
 37 with the Office of Licensing and Certification Programs of the Department that the
 38 geriatric nursing assistant complies with the applicable standards under the
 39 regulations adopted under § 19-308.1 of the Health - General Article.]

1 [(h)] (G) (1) A nursing staff agency may not knowingly provide or refer a
 2 licensed practical nurse who is not authorized to practice licensed practical nursing
 3 under [this title] TITLE 8 OF THE HEALTH OCCUPATIONS ARTICLE to a health care
 4 facility to render temporary nursing services.

5 (2) A nursing staff agency may not knowingly provide or refer a
 6 registered nurse who is not authorized to practice registered nursing under [this
 7 title] TITLE 8 OF THE HEALTH OCCUPATIONS ARTICLE to a health care facility to
 8 render temporary nursing services.

9 (3) ~~A NURSING STAFF AGENCY MAY NOT KNOWINGLY PROVIDE OR ONLY
 10 REFER A CERTIFIED NURSING ASSISTANT WHO IS CERTIFIED UNDER TITLE 8,
 11 SUBTITLE 6-6A OF THE HEALTH OCCUPATIONS ARTICLE TO PERFORM DELEGATED
 12 NURSING FUNCTIONS TO PRACTICE CERTIFIED NURSING UNDER TITLE 8 OF THE
 13 HEALTH OCCUPATIONS ARTICLE TO A HEALTH CARE FACILITY TO RENDER
 14 TEMPORARY DELEGATED NURSING SERVICES. A NURSING STAFF AGENCY MAY NOT
 15 KNOWINGLY PROVIDE OR REFER A CERTIFIED NURSING ASSISTANT WHO IS NOT
 16 AUTHORIZED TO PRACTICE AS A CERTIFIED NURSING ASSISTANT UNDER TITLE 8,
 17 SUBTITLE 6A OF THE HEALTH OCCUPATIONS ARTICLE TO A HEALTH CARE FACILITY
 18 TO RENDER DELEGATED NURSING SERVICES.~~

19 [(i)] (H) (1) Except as provided in paragraph (2) of this subsection:

20 (i) If a nursing staff agency knows of an action or condition
 21 performed by a licensed practical nurse [or], registered nurse, OR CERTIFIED
 22 NURSING ASSISTANT provided or referred by that nursing staff agency that might be
 23 grounds for action under § 8-316 of [this title] THE HEALTH OCCUPATIONS ARTICLE,
 24 the nursing staff agency shall report the action or condition to the Board; and

25 (ii) An individual shall have immunity from liability described
 26 under § 5-709 of the Courts and Judicial Proceedings Article for making a report as
 27 required under this paragraph.

28 (2) A nursing staff agency is not required under this subsection to make
 29 any report that would be in violation of any federal or State law, rule, or regulation
 30 concerning the confidentiality of alcohol and drug abuse patient records.

31 [(j)] (I) (1) Subject to the provisions of Title 10, Subtitle 2 of the State
 32 Government Article, the [Board] OFFICE may impose a penalty of up to \$2,000 for a
 33 violation of any provision of this section;

34 (I) ~~FOR A FIRST OFFENSE, UP TO \$2,500 PER VIOLATION OR UP TO
 35 \$2,500 PER DAY IN VIOLATION UNTIL THE NURSING STAFF AGENCY COMPLIES WITH
 36 THE REQUIREMENTS OF THIS SUBTITLE;~~

37 (II) ~~FOR A SECOND OFFENSE, UP TO \$5,000 PER VIOLATION OR UP
 38 TO \$5,000 PER DAY IN VIOLATION UNTIL THE NURSING STAFF AGENCY COMPLIES

1 (III) FOR A THIRD OR SUBSEQUENT OFFENSE, UP TO \$10,000 PER
