CHAPTER 66

1 AN ACT concerning

2 **Charles County - County Commissioners - Salary**

3 FOR the purpose of altering the salaries for the County Commissioners and the
4 President of the County Commissioners; and providing that this Act does not
5 apply to the salary or compensation of the incumbent County Commissioners or
6 President of the County Commissioners.

7 BY repealing and reenacting, with amendments,
8 The Public Local Laws of Charles County
9 Section 27-2 B and C
10 Article 9 - Public Local Laws of Maryland
11 (1994 Edition and June 1998 Supplement, as amended)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article 9 - Charles County**

15 27-2.

16 B. The salary of the President of the County Commissioners is:

17 [(1) \$39,250 for calendar years 1997 and 1998; and

18 (2) \$45,000 for calendar year 1999 and for each subsequent calendar
19 year.]

20 (1) \$45,000 FOR CALENDAR YEAR 1999 THROUGH CALENDAR YEAR 2002;

- 1 (2) \$47,000 PER YEAR BEGINNING JANUARY 1, 2003;
2 (3) \$48,000 PER YEAR BEGINNING JANUARY 1, 2004;
3 (4) \$49,000 PER YEAR BEGINNING JANUARY 1, 2005; AND
4 (5) \$50,000 PER YEAR BEGINNING JANUARY 1, 2006 AND EACH
5 SUBSEQUENT YEAR.

6 C. The salary for the other County Commissioners is:

- 7 [(1) \$29,700 for calendar years 1997 and 1998; and
8 (2) \$35,000 for calendar year 1999 and for each subsequent calendar
9 year.]
10 (1) \$35,000 FOR CALENDAR YEAR 1999 THROUGH CALENDAR YEAR 2002;
11 (2) \$37,000 PER YEAR BEGINNING JANUARY 1, 2003;
12 (3) \$38,000 PER YEAR BEGINNING JANUARY 1, 2004;
13 (4) \$39,000 PER YEAR BEGINNING JANUARY 1, 2005; AND
14 (5) \$40,000 PER YEAR BEGINNING JANUARY 1, 2006 AND EACH
15 SUBSEQUENT CALENDAR YEAR.

16 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III,
17 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or
18 apply to the salary or compensation of the County Commissioners or the President of
19 the County Commissioners of Charles County in office on the effective date of this
20 Act, but the provisions of this Act concerning the salary or compensation of the
21 County Commissioners and the President of the County Commissioners of Charles
22 County shall take effect at the beginning of the next following term of office.

23 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2001.
