AMENDMENTS TO HOUSE BILL NO. 1190

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 10, strike “exempting” and substitute “altering an exemption from the requirement to pay a certain tax for”; strike beginning with “for” in line 10 down through “tax” in line 11 and substitute “under certain circumstances”; and in line 13, after “terms;” insert “exempting certain fire boats from certain registration fees; exempting certain persons from the payment of the vessel excise tax on certain vessels that are held for resale or repair by certain persons in the State, under certain circumstances;”.

On page 1, in line 16, strike “(s)” and substitute “(n) and (p) through (s)”; in line 17, strike “(t)” and substitute “(o) and (q) through (t)”; in line 27, after “8-701(c)” insert “and (o)”.

AMENDMENT NO. 2

On page 2, after line 24, insert:

“(p) “State of principal use” means the state on whose waters a vessel is used or to be used most during a calendar year WHICH IS THE PERIOD FROM JANUARY 1 THROUGH DECEMBER 31.”.

AMENDMENT NO. 3

On page 3, in line 18, after “boats” insert “AND FIRE BOATS”; in line 21, strike the brackets; and in the same line, strike “2”.

AMENDMENT NO. 4

On page 4, in line 14, strike “UNDERWATER” and substitute “ON-THE-WATER”; in line 15, after “DAY,” insert “THAT IS”; in the same line, after “CONDUCTED” insert “:

(I)”;

and in line 16, after “PROCEDURES” insert “; OR

(II) FOR A VESSEL HELD FOR RESALE BY A LICENSED DEALER UNDER THIS SECTION”.

AMENDMENT NO. 5

On page 4, after line 30, insert:

“(3) THE HOLDING OF A VESSEL THAT IS TITLED OR NUMBERED IN ANOTHER STATE OR IS FEDERALLY DOCUMENTED, PROVIDED:

(I) THE VESSEL IS HELD FOR RESALE OR LISTED FOR RESALE BY A LICENSED DEALER; AND

(II) THE VESSEL OWNER SIGNS AN AFFIDAVIT THAT THERE WILL BE NO USE OF THE VESSEL ON THE WATERS OF THE STATE OTHER THAN FOR A SEA TRIAL;”.

On page 4, in lines 31, 32, and 34 and on page 5, in lines 1, 4, 7, and 18, strike “(3)”, “(4)”, “(5)”, “(6)”, “(7)”, “(8)”, and “(9)”, respectively, and substitute “(4)”, “(5)”, “(6)”, “(7)”, “(8)”, “(9)”, and “(10)”, respectively.

AMENDMENT NO. 6

On page 5, in line 6, after “sought” insert “, EXCEPT THAT:

(I) A VESSEL IS NOT DEEMED USED ON THE WATERS OF THE STATE IF THE VESSEL IS USED FOR 90 DAYS OR LESS OF A CALENDAR YEAR; AND

(II) IF A VESSEL IS USED FOR MORE DAYS THAN 90 DAYS IN A CALENDAR YEAR, THE PERIOD OF 90 DAYS SHALL BE COUNTED IN THE DETERMINATION OF PRINCIPAL USE UNDER THIS SUBTITLE”;

and strike in their entirety lines 26 through 29, inclusive.
