AMENDMENTS TO HOUSE BILL NO. 1443

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 4, after “which” insert “certain”; in line 6, after “certain” insert “earnings”; in the same line, after “limitations” insert “and certain reemployment restrictions”; in lines 6 and 7, in each instance, strike “ordinary or” and substitute “ordinary,”; in lines 6 and 7, in each instance, after “special” insert “, or accidental”; and in line 7, after the semicolon insert “exempting from certain earnings limitations and certain reemployment restrictions certain retirees of the State Police Retirement System and Law Enforcement Officers’ Pension System;”.

AMENDMENT NO. 2

On page 1, in line 19, strike “DOES NOT APPLY” and substitute “APPLIES”; in line 20, after “SYSTEM” insert “OR THE LAW ENFORCEMENT OFFICERS’ PENSION SYSTEM”
WHO:

(1) RETIREES ON OR AFTER JULY 1, 2002;

(2)”;
in the same line, strike “RECEIVING” and substitute “RECEIVES”; in the same line, strike “ORDINARY OR” and substitute “ORDINARY, “; in the same line, after “SPECIAL” insert “, OR ACCIDENTAL”; strike beginning with “ALLOWANCE” in line 21 down through “MEMBER” in line 23 and substitute “ALLOWANCE; AND

(3)”;
and in line 23, strike “EMPLOYED” and substitute “REEMPLOYED”.

AMENDMENT NO. 3

(Over)

On page 2, in line 33, strike “DOES NOT APPLY” and substitute “APPLIES”; in line 34, after “SYSTEM” insert “OR THE LAW ENFORCEMENT OFFICERS’ PENSION SYSTEM WHO:

(1) RETIREES ON OR AFTER JULY 1, 2002;

(2)”;

in the same line, strike “RECEIVING” and substitute “RECEIVES”; in the same line, strike “ORDINARY OR” and substitute “ORDINARY, “; in the same line, after “SPECIAL” insert “, OR ACCIDENTAL”; strike beginning with “ALLOWANCE” in line 35 down through “MEMBER” in line 37 and substitute “ALLOWANCE; AND

(3)”;

and in line 37, strike “EMPLOYED” and substitute “REEMPLOYED”.

AMENDMENT NO. 4

On page 3, in line 2, after “ordinary” insert “, SPECIAL, OR ACCIDENTAL”; in line 11, after “ordinary” insert “, SPECIAL, OR ACCIDENTAL”; strike in their entirety lines 18 through 20, inclusive; and in line 21, strike “3.” and substitute “2.”.
