AMENDMENTS TO HOUSE BILL NO. 917

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with "obtain" in line 3 down through "research;" in line 8 and substitute "comply with federal regulations on the protection of human subjects;"; strike beginning with "open" in line 10 down through "information;" in line 11 and substitute "made available upon request within a certain period of time;"; in line 16, strike "13-1606" and substitute "13-1604"; and in the same line, strike "included".

AMENDMENT NO. 2

On page 2, strike beginning with "MEANS" in line 9 down through "INFORMATION" in line 13 and substitute "HAS THE MEANING STATED IN THE FEDERAL REGULATIONS ON THE PROTECTION OF HUMAN SUBJECTS"; strike beginning with "MEANS" in line 14 down through "SUBJECT" in line 17 and substitute "HAS THE MEANING STATED IN THE FEDERAL REGULATIONS ON THE PROTECTION OF HUMAN SUBJECTS"; strike beginning with "MEANS" in line 18 down through "KNOWLEDGE" in line 20 and substitute "HAS THE MEANING STATED IN THE FEDERAL REGULATIONS ON THE PROTECTION OF HUMAN SUBJECTS"; and strike in their entirety lines 21 and 22.

AMENDMENT NO. 3

On page 2, strike in their entirety lines 24 through 26, inclusive, and substitute:

- "(A) A PERSON MAY NOT CONDUCT RESEARCH USING A HUMAN SUBJECT UNLESS THE PERSON CONDUCTS THE RESEARCH IN ACCORDANCE WITH THE FEDERAL REGULATIONS ON THE PROTECTION OF HUMAN SUBJECTS.
- (B) NOTWITHSTANDING ANY PROVISION IN THE FEDERAL REGULATIONS
 ON THE PROTECTION OF HUMAN SUBJECTS THAT LIMITS THE APPLICABILITY OF
 THE FEDERAL REGULATIONS TO CERTAIN RESEARCH, SUBSECTION (A) OF THIS

SECTION APPLIES TO ALL RESEARCH USING A HUMAN SUBJECT.". AMENDMENT NO. 4

On pages 2 through 4, strike in their entirety the lines beginning with line 27 on page 2 through line 21 on page 4, inclusive, and substitute:

"13-1603.

- (A) AN INSTITUTIONAL REVIEW BOARD SHALL MAKE THE FINAL MINUTES OF A MEETING AVAILABLE FOR INSPECTION WITHIN 30 DAYS OF RECEIPT OF A REQUEST FOR THE MINUTES FROM ANY PERSON.
- (B) PRIOR TO MAKING THE MINUTES OF A MEETING AVAILABLE FOR INSPECTION UNDER SUBSECTION (A) OF THIS SECTION, AN INSTITUTIONAL REVIEW BOARD MAY REDACT CONFIDENTIAL OR PRIVILEGED INFORMATION.
- (C) THE MINUTES OF A MEETING OF AN INSTITUTIONAL REVIEW BOARD ARE NOT PUBLIC RECORDS UNDER TITLE 10, SUBTITLE 6 OF THE STATE GOVERNMENT ARTICLE.".

AMENDMENT NO. 5

On page 4, in line 22, strike "13-1606." and substitute "<u>13-1604.</u>"; strike beginning with "RESEARCH" in line 24 down through "OF" in line 25 and substitute "<u>HUMAN SUBJECT RESEARCH IN VIOLATION OF THE FEDERAL REGULATIONS ON THE PROTECTION OF HUMAN SUBJECTS OR</u>"; in line 27, after "GENERAL" insert "<u>MAY NOT</u>"; in line 28, strike "SHALL AVOID DUPLICATION OF" and substitute "<u>DUPLICATE THE</u>"; in line 30, strike "AND" and substitute "<u>OR</u>"; and in line 31, strike "MAY NOT".
