- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 18 IN THIS SUBTITLE, "FUND" MEANS AN INMATE WELFARE FUND ESTABLISHED
- 19 UNDER § 11-902 OF THIS SUBTITLE.
- 20 11-902.
- 21 (A) THERE IS AN INMATE WELFARE FUND IN EACH LOCAL CORRECTIONAL
- 22 FACILITY.
- 23 (B) A FUND MAY BE USED ONLY FOR GOODS AND SERVICES THAT BENEFIT
- 24 THE GENERAL INMATE POPULATION AS DEFINED BY REGULATIONS THAT THE
- 25 SECRETARY ADOPTS.

- 2 (A) (1) EACH FUND IS A SPECIAL CONTINUING, NONLAPSING FUND THAT IS 3 NOT SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.
- 4 (2) (I) EACH FUND CONSISTS OF:
- 5 1. PROFITS DERIVED FROM THE SALE OF GOODS THROUGH
- 6 THE COMMISSARY OPERATION AND TELEPHONE AND VENDING MACHINE
- 7 COMMISSIONS: AND
- 8 2. SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH,
- 9 MONEY RECEIVED FROM OTHER SOURCES.
- 10 (II) MONEY FROM THE GENERAL FUND OF THE STATE OR COUNTY
- 11 MAY NOT BE TRANSFERRED BY BUDGET AMENDMENT OR OTHERWISE TO A FUND.
