22 (A) THE PRINCE GEORGE'S COUNTY CITIZEN COMPLAINT OVERSIGHT PANEL
23 MAY PETITION A COURT OF COMPETENT JURISDICTION TO ISSUE AN ORDER
24 REQUIRING COMPLIANCE WITH A SUBPOENA ISSUED FOR THE PANEL BY THE
25 COUNTY COUNCIL.

26 (B) A COURT OF COMPETENT JURISDICTION MAY HOLD A PERSON WHO FAILS
27 TO OBEY AN ORDER ISSUED UNDER SUBSECTION (A) OF THE SECTION IN CONTEMPT
28 OF COURT.

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
30 October 1, 2002.
