CHAPTER 309

1 AN ACT concerning

2 **Motor Vehicle Administration - Drivers' Licenses and Identification Cards -**
3 **Selective Service Administration Registration**

4 FOR the purpose of requiring the Motor Vehicle Administration to provide to the
5 Selective Service Administration certain information concerning male
6 applicants of a certain age who apply for a driver's license or identification card
7 under certain circumstances; establishing that a signature on an application for
8 a driver's license or identification card ~~constitutes consent to~~ indicates that the
9 applicant has selected one of the options on the application form concerning the
10 forwarding of certain information to the Selective Service Administration;
11 requiring the Motor Vehicle Administration to provide certain information on a
12 certain application; ~~providing that an applicant's refusal to consent to certain~~
13 ~~information being sent to the Selective Service Administration does not~~
14 ~~constitute grounds for denial of a driver's license or identification card;~~
15 providing that an applicant's refusal to consent to certain information being sent
16 to the Selective Service Administration does not constitute grounds for denial of a
17 driver's license or identification card; requiring the Motor Vehicle

1 Administration to forward certain information to the Selective Service
 2 Administration in a certain manner; making certain provisions of this Act
 3 contingent on certain federal funding; requiring the Motor Vehicle Administrator
 4 to take certain actions regarding federal funding to implement certain provisions
 5 of this Act; and generally relating to drivers' licenses and identification cards.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 12 MARYLAND, That the Laws of Maryland read as follows:

13 **Article - Transportation**

15 (A) THIS SECTION APPLIES ONLY TO AN ADULT MALE APPLICANT UNDER THE
 16 AGE OF 26 YEARS.

17 (B) SUBJECT TO SUBSECTION (C) OF THIS SECTION, THE ADMINISTRATION
 18 SHALL PROVIDE TO THE SELECTIVE SERVICE ADMINISTRATION IN AN ELECTRONIC
 19 FORMAT, FOR PURPOSES OF REGISTRATION WITH THE SELECTIVE SERVICE AS
 20 REQUIRED UNDER FEDERAL LAW, THE NECESSARY INFORMATION CONCERNING A
 21 MALE APPLICANT WHO APPLIES FOR A DRIVER'S LICENSE OR IDENTIFICATION CARD
 22 OR THE RENEWAL OF A DRIVER'S LICENSE OR IDENTIFICATION CARD, INCLUDING
 23 THE APPLICANT'S:

- 24 (1) FULL NAME;
- 25 (2) CURRENT ADDRESS;
- 26 (3) DATE OF BIRTH;
- 27 (4) GENDER;
- 28 (5) DATE OF APPLICATION; AND
- 29 (6) SOCIAL SECURITY NUMBER, IF AVAILABLE.

35 SECTION 2. AND BE IT FURTHER ENACTED, That Section 1 of this Act is
 36 contingent on the receipt by the Motor Vehicle Administration of sufficient federal
 37 funds to pay the Administration's initial start-up costs for computer programming
 38 changes necessary to implement the requirements of Section 1 of this Act related to the
 39 reporting of information to the Selective Service Administration.

1 SECTION 3. AND BE IT FURTHER ENACTED, That the Motor Vehicle
2 Administrator shall initiate and monitor efforts to obtain federal funds for the
3 purposes stated in Section 2 of this Act and shall report promptly to the Department of
4 Legislative Services when federal funds have been received by the Administration and
5 the contingency specified in Section 2 of this Act has been fulfilled.

6 SECTION ~~2. 4.~~ AND BE IT FURTHER ENACTED, That, subject to Section 2
7 of this Act, this Act shall take effect October 1, 2002.
