CHAPTER 559

1 AN ACT concerning

2 **State Commission on Criminal Sentencing Policy - Annual Report**

3 FOR the purpose of requiring the annual report of the State Commission on Criminal
4 Sentencing Policy to include information on certain sentences altered as a result
5 of a reconsideration of sentence; requiring the report to categorize information
6 on the number of reconsiderations of sentence granted by crime and judicial
7 circuit; and generally relating to the annual report of the State Commission on
8 Criminal Sentencing Policy.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

Article - Criminal Procedure

2 6-209.

3 (a) The Commission shall review annually sentencing policy and practice and,
4 on or before December 1 of each year, report to the General Assembly in accordance
5 with § 2-1246 of the State Government Article.

6 (b) (1) The report shall:

7 (i) include any changes to the sentencing guidelines made during
8 the preceding year; [and]

9 (ii) review judicial compliance with the sentencing guidelines,
10 including compliance by crime and by judicial circuit;

11 (III) REVIEW REDUCTIONS OR INCREASES IN ORIGINAL SENTENCES
12 THAT HAVE OCCURRED BECAUSE OF RECONSIDERATIONS OF SENTENCES IMPOSED
13 UNDER § 14-101 OF THE CRIMINAL LAW ARTICLE; AND

14 (IV) CATEGORIZE INFORMATION ON THE NUMBER OF
15 RECONSIDERATIONS OF SENTENCES BY CRIMES AS LISTED IN § 14-101(A) OF THE
16 CRIMINAL LAW ARTICLE AND BY JUDICIAL CIRCUIT.

17 (2) The Commission shall consider a sentence to a corrections options
18 program to be within the sentencing guidelines if the sentence falls within a
19 corrections options zone shown on the matrix.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 October 1, 2002.
