CHAPTER 70

1 AN ACT concerning

2 **Kent County - Alcoholic Beverages - Special Theater License**

3 FOR the purpose of establishing in Kent County a special theater (on-sale) beer, wine
4 and liquor license; specifying certain application requirements and fees for the
5 issuance of the license and fee and the times of sale of beer, wine, or liquor by
6 the license holder; prohibiting the license from being transferred under certain
7 circumstances; ~~making certain population requirements inapplicable to a~~
8 ~~special theater license~~; defining a term; and generally relating to a special
9 theater license in Kent County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article 2B - Alcoholic Beverages**

18 8-215.

19 (A) IN THIS SECTION, "BOARD" MEANS THE KENT COUNTY BOARD OF LICENSE
20 COMMISSIONERS.

21 (B) THERE IS A SPECIAL THEATER (ON-SALE) BEER, WINE AND LIQUOR
22 LICENSE IN KENT COUNTY.

1 (C) THE BOARD MAY ISSUE A SPECIAL THEATER (ON-SALE) BEER, WINE AND
2 LIQUOR LICENSE FOR USE IN A THEATER IF THE THEATER:

3 (1) IS HOUSED WITHIN A BUILDING;

4 (2) HAS A CAPACITY TO HOLD A MINIMUM OF 150 PERMANENTLY
5 INSTALLED SEATS; AND

6 (3) REGULARLY PRESENTS LIVE ENTERTAINMENT.

7 (D) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ARTICLE, A HOLDER
8 MAY SELL BEER, WINE, AND LIQUOR AT RETAIL FOR ON-PREMISES CONSUMPTION:

9 (1) FOR 2 HOURS BEFORE THE ENTERTAINMENT BEGINS;

10 (2) DURING THE ENTERTAINMENT; AND

11 (3) FOR 1 HOUR AFTER THE ENTERTAINMENT ENDS.

12 (E) THE ANNUAL LICENSE FEE IS \$500.

13 (F) A SPECIAL THEATER (ON-SALE) BEER, WINE AND LIQUOR LICENSE MAY
14 NOT BE TRANSFERRED TO A LOCATION OTHER THAN THE LOCATION OF ORIGINAL
15 ISSUANCE.

16 ~~(G) THE POPULATION REQUIREMENTS OF THE RULES AND REGULATIONS OF~~
17 ~~THE BOARD DO NOT APPLY TO A LICENSE ISSUED UNDER THIS SECTION.~~

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 June 1, 2002.
