15 16	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
17	Article - Insurance

19 20	(a) In this section, "mastectomy" means the surgical removal of all or part of a breast as a result of breast cancer.

- 1 (b) This section applies to:
- 2 (1) insurers and nonprofit health service plans that provide inpatient
- 3 hospital, medical, or surgical benefits to individuals or groups on an
- 4 expense-incurred basis under health insurance policies or contracts that are issued or
- 5 delivered in the State; and
- 6 (2) health maintenance organizations that provide inpatient hospital,
- 7 medical, or surgical benefits to individuals or groups under contracts that are issued
- 8 or delivered in the State.
- 9 (c) For a patient who receives less than 48 hours of inpatient hospitalization
- 10 following a mastectomy or the surgical removal of a testicle, or who undergoes a
- 11 mastectomy or the surgical removal of a testicle on an outpatient basis, an entity
- 12 subject to this section shall provide coverage for:
- 13 (1) one home visit scheduled to occur within 24 hours after discharge
- 14 from the hospital or outpatient health care facility; and
- 15 (2) an additional home visit if prescribed by the patient's attending
- 16 physician.
- 17 (d) Each entity subject to this section shall provide notice annually to its
- 18 enrollees and insureds about the coverage required under this section.

## 19 **Chapter 120 of the Acts of 1999**

- 20 SECTION 7. AND BE IT FURTHER ENACTED, That, except as provided in
- 21 Section 6 of this Act, this Act shall take effect October 1, 1999. [Section 2 of this Act
- 22 shall remain effective for a period of 4.7 years and, at the end of September 30, 2003
- 23 2006, with no further action required by the General Assembly, Section 2 of this Act
- 24 shall be abrogated and of no further force and effect.
- 25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 26 October 1, 2003.
