CHAPTER 124

1 AN ACT concerning

2 **Worcester County - Alcoholic Beverages - Sunday Sales**

3 FOR the purpose of altering in Worcester County the time at which certain licensed  
4 premises may open for the sale of certain alcoholic beverages on Sunday; and  
5 generally relating to the Sunday sale of alcoholic beverages in Worcester County.

6 BY repealing and reenacting, with amendments,  
7 Article 2B - Alcoholic Beverages  
8 Section 11-524(c)(2)(ii)(C), (4)(ii)(C), (6)(ii)(C), (8)(ii)(C), (9)(ii)(C), (10)(iii), and

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

27 beer and light wine only].

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take  
29 effect June 1, 2003.
