3 (RR) (1) IN THIS SUBSECTION, "GOVERNMENT ORGANIZATION" INCLUDES:

4 (I) A COUNTY;

5 (II) A BOARD OF EDUCATION;

6 (III) A MUNICIPAL CORPORATION; OR

7 (IV) A GOVERNMENT COOPERATIVE PURCHASING ORGANIZATION.
