CHAPTER 169

1 AN ACT concerning

2 **Frederick County - Alcoholic Beverages Licenses - Maryland Ensemble**
3 **Theatre**

4 FOR the purpose of renaming a certain special Class C on-sale beer and wine license
5 in Frederick County to be the special Class C (Maryland Ensemble Theatre)
6 on-sale beer and wine license; providing for the application for and issuance of
7 the license to the Maryland Ensemble Theatre; and generally relating to
8 alcoholic beverages licenses in Frederick County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
20 MARYLAND, That the Laws of Maryland read as follows:

Article 2B - Alcoholic Beverages

2 6-301.

3 (l) (1) The provisions of this subsection apply only in Frederick County.

4 (9) (i) There is a special Class C [(Cultural Arts Center)] (MARYLAND
5 ENSEMBLE THEATRE) on-sale beer and wine license.6 (ii) On approval by the Board of License Commissioners of
7 Frederick County of the license application, the Board shall issue a license for the
8 [Cultural Arts Center of Frederick County] MARYLAND ENSEMBLE THEATRE.

9 (iii) The annual license fee is \$100.

10 (iv) The licensee may store for sale and sell beer and wine to the
11 public.12 (v) The beer and wine shall be consumed on the premises not
13 earlier than 1 hour before and not later than 1 hour after:

14 1. A regular performance; or

15 2. A special fund-raiser performance exclusively for the
16 benefit of the ~~Cultural Arts Center~~ MARYLAND ENSEMBLE THEATRE.17 (vi) The president and two other officers of Maryland Ensemble
18 Theatre shall sign the application for the license filed on behalf of the [Cultural Arts
19 Center] MARYLAND ENSEMBLE THEATRE.20 (vii) Two of the signatories from Maryland Ensemble Theatre shall
21 be residents of Frederick County.22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
23 effect June 1, 2003.
