3 FOR the purpose of authorizing the Washington County Board of County

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

17 MARYLAND, That the Laws of Maryland read as follows:

Article 66B - Land Use

20 (A) IN THIS SECTION, "PUBLIC FACILITIES" MEANS SCHOOLS, ROADS, WATER 21 AND SEWER WATER, WASTEWATER, AND STORMWATER MANAGEMENT FACILITIES, 22 AND OTHER INFRASTRUCTURE SUPPORTED BY THE FEDERAL, STATE, OR LOCAL

23 GOVERNMENT FOR PUBLIC PURPOSES.

1 (B) EXCEPT FOR LAND WITHIN A MUNICIPAL CORPORATION IN WASHINGTON 2 COUNTY, THIS SECTION APPLIES TO WASHINGTON COUNTY.

3 (C) IN ADDITION TO THE AUTHORITY GRANTED IN § 10.01 OF THIS ARTICLE,
4 THE COUNTY COMMISSIONERS MAY PROVIDE, BY ORDINANCE, FOR THE PROVISION
5 AND FINANCING OF ADEQUATE PUBLIC FACILITIES CONCURRENTLY WITH THE
6 NEED FOR THOSE FACILITIES.

7 (D) THE ORDINANCE MAY INCLUDE THE AUTHORITY FOR THE COUNTY 8 COMMISSIONERS TO:

9 (1) DETERMINE THE <u>FUNCTIONAL OR</u> DESIGN CAPACITY OF PUBLIC 10 FACILITIES;

11 (2) ESTABLISH STANDARDS FOR DETERMINING THE ADEQUACY OF 12 PUBLIC FACILITIES;

13 (3) DETERMINE SCHOOL CAPACITY STANDARDS;

14 (4) DETERMINE THE STUDENT YIELD FACTORS FOR SCHOOLS AT 15 VARIOUS LEVELS;

16 (5) ESTABLISH CATEGORIES OF DEVELOPMENTS THAT WILL BE EXEMPT 17 FROM THE APPLICATION OF THE ORDINANCE;

18 (6) ESTABLISH FORMULAS FOR MEASURING AVAILABLE CAPACITY OF 19 PUBLIC FACILITIES;

20(7)DETERMINE THE ADEQUACY OF PUBLIC FACILITIES IN AREAS21AFFECTED BY NEW DEVELOPMENTS IN THE DEVELOPMENT PLAN REVIEW PROCESS;

(8) ENTER INTO AGREEMENTS WITH DEVELOPERS PROVIDING FOR THE
PAYMENT OF MONETARY COMPENSATION TO ADDRESS INADEQUACIES IN PUBLIC
FACILITIES CAUSED BY PROPOSED DEVELOPMENTS AS A PART OF THE
DEVELOPMENT PLAN APPROVAL PROCESS;

26 (9) DETERMINE THE VALUE OF IN-KIND CONTRIBUTIONS OF 27 EQUIVALENT VALUE SUCH AS REAL ESTATE;

28 (10) FORFEIT REQUIRE FORFEITURE OF CONTRIBUTIONS 3 YEARS AFTER
 29 FINAL PLAT APPROVAL;

30 (11) ESTABLISH AN APPEAL PROCESS FOR DECISIONS MADE UNDER THE 31 ORDINANCE;

32 (12) LIMIT THE NUMBER OF BUILDING PERMITS IN ANY SCHOOL 33 DISTRICT; AND

34 (13) LIMIT THE NUMBER OF RESIDENTIAL BUILDING LOTS APPROVED
 35 FOR DEVELOPMENT ON AN ANNUAL BASIS.

1 (E) THE ORDINANCE UNDER SUBSECTION (D) OF THIS SECTION MAY

2 AUTHORIZE THE COUNTY COMMISSIONERS TO IMPOSE CIVIL FINES AND PENALTIES

3 FOR ANY VIOLATION OF THE ORDINANCE.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act does not apply to

5 any development or proposed development in Washington County with respect to
6 which a preliminary plat was formally approved prior to July 1, 2003.

7 SECTION 2. <u>3.</u> AND BE IT FURTHER ENACTED, That this Act shall take 8 effect July 1, 2004.
