CHAPTER 102

1 AN ACT concerning

2 **Anne Arundel County - Right to Farm**

3 FOR the purpose of authorizing the County Council of Anne Arundel County to adopt
4 an ordinance, resolution, or regulation or take other action that the County
5 Council considers necessary to protect a person's right to farm or engage in
6 agricultural or forestry operations; requiring the County Council to hold a public
7 hearing and provide reasonable notice of the hearing before adopting a certain
8 ordinance, resolution, or regulation or taking other action under certain
9 circumstances; and generally relating to the authority of the County Council of
10 Anne Arundel County to protect a person's right to farm.

7 (A) SUBJECT TO SUBSECTION (B) OF THIS SECTION, THE COUNTY COUNCIL OF
8 ANNE ARUNDEL COUNTY MAY ADOPT AN ORDINANCE, RESOLUTION, OR
9 REGULATION OR TAKE ANY OTHER ACTION THAT THE COUNTY COUNCIL CONSIDERS
10 NECESSARY TO PROTECT A PERSON'S RIGHT TO FARM OR ENGAGE IN AGRICULTURAL
11 OR FORESTRY OPERATIONS.

12 (B) BEFORE ADOPTING AN ORDINANCE, RESOLUTION, OR REGULATION OR
13 TAKING OTHER ACTION UNDER SUBSECTION (A) OF THIS SECTION, THE COUNTY
14 COUNCIL SHALL HOLD A PUBLIC HEARING AND PROVIDE REASONABLE NOTICE OF
15 THE HEARING.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2004.
