CHAPTER 176

1 AN ACT concerning

2 **Allegheny County and Garrett County - Alcoholic Beverages Licenses -**
3 **Out-of-State Restriction**

4 FOR the purpose of prohibiting in Allegheny County and Garrett County certain
5 alcoholic beverages licenses from being issued, except by renewal, to persons,
6 corporations, or limited liability companies that hold an alcoholic beverages
7 license in any other state or Washington, D.C.; making a stylistic change; and
8 generally relating to alcoholic beverages licenses in Allegheny County and
9 Garrett County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article 2B - Alcoholic Beverages**

5 (b-3) (1) IN ALLEGANY COUNTY, A CLASS A OR CLASS D BEER, BEER AND
6 LIGHT WINE, OR BEER, WINE AND LIQUOR LICENSE MAY NOT BE ISSUED, EXCEPT BY
7 WAY OF RENEWAL, TO A PERSON, CORPORATION, OR LIMITED LIABILITY COMPANY
8 HOLDING AN ALCOHOLIC BEVERAGES LICENSE IN ANY OTHER STATE OR IN
9 WASHINGTON, D.C.

10 [(1)] (2) In Anne Arundel County, a Class A or Class D beer, beer and
11 light wine, or beer, wine and liquor license may not be issued except by way of
12 renewal to a person, corporation, or limited liability company holding an alcoholic
13 beverage license in any other state[,] or Washington, D.C.

14 [(2)] (3) In Baltimore City, a Class A or Class D beer, beer and light
15 wine, or beer, wine and liquor license may not be issued except by way of renewal to
16 a person, corporation, or limited liability company holding an alcoholic beverage
17 license in any other state.

18 [(3)] (4) In Baltimore County, a Class A or Class D beer, beer and light
19 wine, or beer, wine and liquor license may not be issued, except by way of renewal, to
20 a person, corporation, or limited liability company holding an alcoholic beverages
21 license in any other state or in Washington, D.C.

22 [(4)] (5) In Calvert County and St. Mary's County, a Class A or Class D
23 beer, beer and light wine, or beer, wine and liquor license may not be issued, except by
24 way of renewal, to a person, corporation, or limited liability company holding an
25 alcoholic beverages license in any other state or in Washington, D.C.

26 [(5)] (6) In Charles County, a Class A or Class D beer, beer and light
27 wine, or beer, wine and liquor license may not be issued, except by way of renewal, to
28 a person, corporation, or limited liability company holding an alcoholic beverages
29 license in any other state or in Washington, D.C.

30 (7) IN GARRETT COUNTY, A CLASS A OR CLASS D BEER, BEER AND LIGHT
31 WINE, OR BEER, WINE AND LIQUOR LICENSE MAY NOT BE ISSUED, EXCEPT BY WAY
32 OF RENEWAL, TO A PERSON, CORPORATION, OR LIMITED LIABILITY COMPANY
33 HOLDING AN ALCOHOLIC BEVERAGES LICENSE IN ANY OTHER STATE OR IN
34 WASHINGTON, D.C.

35 [(6)] (8) In Washington County, a Class A or Class D beer, beer and light
36 wine, or beer, wine and liquor license may not be issued, except by way of renewal, to
37 a person, corporation, or limited liability company holding an alcoholic beverages
38 license in any other state or in Washington, D.C.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
