20 (W) ANY PERSON WHO IS CONVICTED OF COMMITTING A VIOLATION OF §
21 21-1003(J) OF THIS ARTICLE WHILE OPERATING A COMMERCIAL MOTOR VEHICLE IN
22 ANNE ARUNDEL COUNTY IS SUBJECT TO:

23 (1) FOR A FIRST OFFENSE, A FINE OF \$100;

24 (2) FOR A SECOND OFFENSE, A FINE OF \$250; AND

25 (3) FOR A THIRD OR SUBSEQUENT OFFENSE, A FINE OF \$500.
