3 **Subsequent Offender**

4 FOR the purpose of ~~altering the~~ establishing a penalty for a person convicted of a  
5 sexual offense in the fourth degree if the person ~~is an offender required to~~

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
 5 MARYLAND, That the Laws of Maryland read as follows:

6 **Article - Criminal Law**

7 3-308.

8 (a) A person may not engage in:

9 (1) sexual contact with another without the consent of the other;

10 (2) except as provided in § 3-307(a)(4) of this subtitle, a sexual act with  
 11 another if the victim is 14 or 15 years old, and the person performing the sexual act is  
 12 at least 4 years older than the victim; or

13 (3) except as provided in § 3-307(a)(5) of this subtitle, vaginal  
 14 intercourse with another if the victim is 14 or 15 years old, and the person performing  
 15 the act is at least 4 years older than the victim.

16 (b) (1) [A] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION,  
 17 A person who violates this section is guilty of the misdemeanor of sexual offense in the  
 18 fourth degree and on conviction is subject to imprisonment not exceeding 1 year or a  
 19 fine not exceeding \$1,000 or both.

34 (a) ~~In this subtitle the following words have the meanings indicated.~~

35 (b) ~~"Child sexual offender" means a person who:~~

1           (1)     has been convicted of violating § 3-602 of the Criminal Law Article;

2           (2)     has been convicted of violating any of the provisions of the rape or  
3 sexual offense statutes under §§ 3-303 through 3-307 of the Criminal Law Article for  
4 a crime involving a child under the age of 15 years;

5           (3)     has been convicted of violating the fourth degree sexual offense  
6 statute under § 3-308 of the Criminal Law Article for a crime involving a child under  
7 the age of 15 years and has been ordered by the court to register under this subtitle;  
8 or

9           (4)     has been convicted in another state or in a federal, military, or Native  
10 American tribal court of a crime that, if committed in this State, would constitute one  
11 of the crimes listed in items (1) and (2) of this subsection.

12        (d)     "Offender" means a person who is ordered by a court to register under this  
13 subtitle and who:

14           (1)     has been convicted of violating § 3-503 of the Criminal Law Article;

15           (2)     has been convicted of violating § 3-502 of the Criminal Law Article or  
16 the fourth degree sexual offense statute under § 3-308 of the Criminal Law Article, if  
17 the victim is under the age of 18 years;

18           (3)     has been convicted of the common law crime of false imprisonment, if  
19 the victim is under the age of 18 years and the person is not the victim's parent;

20           (4)     has been convicted of a crime that involves soliciting a person under  
21 the age of 18 years to engage in sexual conduct;

22           (5)     has been convicted of violating the child pornography statute under §  
23 11-207 of the Criminal Law Article;

24           (6)     has been convicted of violating any of the prostitution and related  
25 crimes statutes under Title 11, Subtitle 3 of the Criminal Law Article if the intended  
26 prostitute or victim is under the age of 18 years;

27           (7)     has been convicted of a crime that involves conduct that by its nature  
28 is a sexual offense against a person under the age of 18 years;

29           (8)     has been convicted of an attempt to commit a crime listed in items (1)  
30 through (7) of this subsection; or

31           (9)     has been convicted in another state or in a federal, military, or Native  
32 American tribal court of a crime that, if committed in this State, would constitute one  
33 of the crimes listed in items (1) through (8) of this subsection.

34        (f)     "Sexually violent offender" means a person who:

35           (1)     has been convicted of a sexually violent offense; or

1           (2)     has been convicted of an attempt to commit a sexually violent offense.

2           (g)     "Sexually violent offense" means:

3           (1)     a violation of §§ 3-303 through 3-307 or §§ 3-309 through 3-312 of  
4 the Criminal Law Article;

5           (2)     assault with intent to commit rape in the first or second degree or a  
6 sexual offense in the first or second degree as prohibited on or before September 30,  
7 1996, under former Article 27, § 12 of the Code; or

8           (3)     a crime committed in another state or in a federal, military, or Native  
9 American tribal jurisdiction that, if committed in this State, would constitute one of  
10 the crimes listed in item (1) or (2) of this subsection.

11          (h)     "Sexually violent predator" means:

12           (1)     a person who:

13                   (i)     is convicted of a sexually violent offense; and

14                   (ii)    has been determined in accordance with this subtitle to be at  
15 risk of committing another sexually violent offense; or

16           (2)     a person who is or was required to register every 90 days for life  
17 under the laws of another state or a federal, military, or Native American tribal  
18 jurisdiction.

20          (a)     A person shall register with the person's supervising authority if the  
21 person is:

22           (1)     a child sexual offender;

23           (2)     an offender;

24           (3)     a sexually violent offender;

25           (4)     a sexually violent predator;

26           (5)     a child sexual offender who, before moving into this State, was  
27 required to register in another state or by a federal, military, or Native American  
28 tribal court for a crime that occurred before October 1, 1995;

29           (6)     an offender, sexually violent offender, or sexually violent predator  
30 who, before moving into this State, was required to register in another state or by a  
31 federal, military, or Native American tribal court for a crime that occurred before July  
32 1, 1997; or

1           (7)     ~~a child sexual offender, offender, sexually violent offender, or sexually~~  
2 ~~violent predator who is required to register in another state, who is not a resident of~~  
3 ~~this State, and who enters this State:~~

4                   (i)     ~~to carry on employment; or~~
