CHAPTER 88

1 AN ACT concerning

2 **Department of Housing and Community Development - Community**
3 **Development Administration - Grants to Home Buyers**

4 FOR the purpose of authorizing the Community Development Administration of the
5 Department of Housing and Community Development to award ~~certain~~ grants
6 to home buyers for settlement expenses under certain circumstances; making
7 stylistic changes; and generally relating to grants to home buyers from the
8 Community Development Administration.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article 83B - Department of Housing and Community Development**

5 (b) (1) The Administration is hereby created as a division of the Department
6 to coordinate the various activities and programs which may contribute to sound
7 community development, to encourage and facilitate the development of new and
8 existing communities by reducing the costs of development through grants, loans, and
9 other forms of financial assistance, to encourage and facilitate energy conservation
10 and the utilization of solar energy in housing and commercial buildings by providing
11 grants, loans, and other forms of financial assistance, making available land for such
12 development and by assisting the efforts of private enterprise, municipalities,
13 counties, local public agencies, local development corporations, and nonprofit
14 organizations.
