# AMENDMENTS TO SENATE BILL NO. 360 (First Reading File Bill)

## AMENDMENT NO. 1

On page 1, strike beginning with "ensure" in line 4 down through "date" in line 10 and substitute "develop, by a certain date, a certain clause relating to nonvisual access for use in the procurement of certain technology; requiring the nonvisual access clause adopted by the governing bodies of certain institutions to be consistent with certain standards developed by the Department of Budget and Management"; in line 12, strike "and use"; strike in their entirety lines 14 through 18, inclusive; in line 21, strike "11-105(b),"; in the same line, strike "and 12-112" and substitute "<u>12-112, and 14-109</u>"; and strike beginning with "12-301" in line 26 down through "14-409," in line 27 and substitute "<u>14-409</u>".

#### AMENDMENT NO. 2

On pages 2 through 4, strike in their entirety the lines beginning with line 11 on page 2 through line 4 on page 4, inclusive.

## AMENDMENT NO. 3

On page 6, in line 1, strike "(1)"; strike in their entirety lines 7 through 12, inclusive, and substitute:

# "(C) <u>BY JANUARY 1, 2007, THE BOARD OF REGENTS SHALL DEVELOP A</u> <u>NONVISUAL ACCESS CLAUSE FOR USE IN THE PROCUREMENT OF COMPUTER-BASED</u> <u>INSTRUCTIONAL TECHNOLOGY.</u>

(D) THE NONVISUAL ACCESS CLAUSE DEVELOPED UNDER SUBSECTION (C) OF THIS SECTION SHALL BE CONSISTENT WITH THE STANDARDS DEVELOPED BY THE DEPARTMENT OF BUDGET AND MANAGEMENT IN ACCORDANCE WITH THE PROVISIONS OF § 3-412 OF THE STATE FINANCE AND PROCUREMENT ARTICLE."; and strike in their entirety lines 13 through 26, inclusive.

# AMENDMENT NO. 4

On page 6, in line 27, strike "14-110." and substitute "<u>14-109.</u>".

On pages 6 and 7, strike in their entirety the lines beginning with line 34 on page 6 through line 16 on page 7, inclusive, and substitute:

"[(a)] (B) (1) Except as provided in § 11-203(e) of the State Finance and Procurement Article, the University is exempt from Division II of the State Finance and Procurement Article.

(2) (i) Subject to review and approval by the Board of Public Works and the Administrative, Executive, and Legislative Review Committee of the General Assembly, the Board of Regents shall develop policies and procedures governing procurements by the University.

(ii) The policies and procedures developed under subparagraph (i) of this paragraph shall promote the purposes of the State procurement law as set forth in § 11-201 of the State Finance and Procurement Article.

[(b)] (C) The Board of Regents shall develop an information technology plan for the University that includes information technology policies and standards, including policies and standards for information management and telecommunication systems, that are functionally compatible with the State Information Technology Plan established under Title 3, Subtitle 4 of the State Finance and Procurement Article.

# (D) BY JANUARY 1, 2007, THE BOARD OF REGENTS SHALL DEVELOP A NONVISUAL ACCESS CLAUSE FOR USE IN THE PROCUREMENT OF COMPUTER-BASED INSTRUCTIONAL TECHNOLOGY.

(E) THE NONVISUAL ACCESS CLAUSE DEVELOPED UNDER SUBSECTION (D) OF THIS SECTION SHALL BE CONSISTENT WITH THE STANDARDS DEVELOPED BY THE DEPARTMENT OF BUDGET AND MANAGEMENT IN ACCORDANCE WITH THE PROVISIONS OF § 3-412 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.".

## AMENDMENT NO. 5

On pages 7 and 8, strike in their entirety the lines beginning with line 24 on page 7 through

line 6 on page 8, inclusive, and substitute:

"(B) BY JANUARY 1, 2007, THE BOARD OF COMMUNITY COLLEGE TRUSTEES FOR EACH COMMUNITY COLLEGE SHALL DEVELOP A NONVISUAL ACCESS CLAUSE FOR USE IN THE PROCUREMENT OF COMPUTER-BASED INSTRUCTIONAL TECHNOLOGY.

(C) THE NONVISUAL ACCESS CLAUSE DEVELOPED UNDER SUBSECTION (B) OF THIS SECTION SHALL BE CONSISTENT WITH THE STANDARDS DEVELOPED BY THE DEPARTMENT OF BUDGET AND MANAGEMENT IN ACCORDANCE WITH THE PROVISIONS OF § 3-412 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.".
