### AMENDMENTS TO HOUSE BILL NO. 402

(First Reading File Bill)

## AMENDMENT NO. 1

On page 1, in line 2, strike "Identification for"; in line 3, after "Distribution" insert "Information"; in line 4, after "maintain" insert ", for a certain period of time,"; in line 5, strike "information of"; in the same line, after "distribution" insert "information"; in line 6, after "sell" insert "or distribute"; in the same line, strike "in" and substitute "under"; in line 7, strike "report" and substitute "make available"; in the same line, strike "at certain times" and substitute "upon a certain request"; and in line 8, strike "prohibiting the Secretary from registering certain distributors" and substitute "requiring the Secretary of Agriculture to maintain certain records in a certain manner except under certain circumstances".

### AMENDMENT NO. 2

On page 1, in line 21, after "MAINTAIN" insert a comma; and in the same line, after "YEARS" insert a comma.

On page 2, in line 4, strike "OUT OF SEASON,"; and in line 5, strike the comma.

## AMENDMENT NO. 3

On page 2, in line 1, strike "AMOUNT" and substitute "QUANTITY"; in the same line, strike the second "THE"; in the same line, after "FERTILIZER" insert "SOLD OR DELIVERED"; in line 3, after "SELL" insert "OR DISTRIBUTE"; in line 4, after "BUYER" insert "OR RECIPIENT"; in the same line, strike "PURCHASE" and substitute "ACQUIRE"; and in line 5, strike "PURCHASE" and substitute "ACQUISITION".

## AMENDMENT NO. 4

On page 2, strike in their entirety lines 6 through 9, inclusive, and substitute:

# "(C) RECORDS MAINTAINED PURSUANT TO SUBSECTION (A) OF THIS

<u>SECTION SHALL BE MADE AVAILABLE TO THE SECRETARY UPON REQUEST</u>"; and strike in their entirety lines 10 through 12, inclusive, and substitute:

- "(D) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, THE SECRETARY SHALL MAINTAIN ALL RECORDS OR REPORTS REQUESTED UNDER SUBSECTION (C) OF THIS SECTION IN A MANNER THAT PROTECTS THE IDENTITY AND LOCATION OF THE DISTRIBUTOR AND BUYER OR RECIPIENT.
- (2) IF THE SECRETARY DETERMINES THAT THE DISCLOSURE IS NECESSARY TO PROTECT THE PUBLIC, THE SECRETARY MAY DISCLOSE THE IDENTITY AND LOCATION OF THE DISTRIBUTOR AND BUYER OR RECIPIENT TO A FEDERAL, STATE, OR LOCAL GOVERNMENT OR UNIT OF GOVERNMENT THAT REQUESTS THE INFORMATION IN THE COURSE OF PERFORMING ITS DUTIES RELATED TO PUBLIC SAFETY."
