On page 3, strike beginning with the first "FOR" in line 1 down through "CONTRACT" in line 2.

On page 5, in line 4, strike "AN" and substitute "<u>ANY</u>"; in the same line, strike "PAYMENT" and substitute "<u>PAYMENTS</u>"; and in line 7, after the comma insert "<u>OF THE NET</u> CONSIDERATIONS PAID PRIOR TO THAT TIME,".

AMENDMENT NO. 4

On page 5, strike beginning with "NOT" in line 29 down through "POINTS" in line 33 and

in line 34, strike "(2)" and substitute "(3)"; and in the same line, strike "PARAGRAPH (1)(II)" and substitute "PARAGRAPHS (1) AND (2)";

On page 6, in line 1, strike "(3)" and substitute "(4)"; in the same line, strike "PARAGRAPH (1)" and substitute "PARAGRAPHS (1) AND (2)"; in line 5, strike "PROVIDE" and substitute "STATE"; strike beginning with "THE" in line 6 down through "3." in line 10 and substitute "WHETHER THE INTEREST RATE WILL BE REDETERMINED; AND

<u>2.</u>";

in line 10, after the comma insert "BASIS,"; strike beginning with the semicolon in line 11 down through "RATE" in line 14; in line 17, strike "(C)(1)(II)" and substitute "(C)(2)(II)"; in line 20, strike "OR AT" and substitute "AND ON"; and in the same line, strike "REDEMPTION" and substitute "REDETERMINATION".
