AMENDMENTS TO HOUSE BILL NO. 159

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in lines 3 and 5, in each instance, strike “repealing” and substitute “altering”; in line 7, strike the comma and substitute a semicolon; in line 9, strike “, on request,”; in the same line, strike “if accompanied by” and substitute “on payment of”; in the same line, after “a” insert “certain”; and in line 10, after “fee” insert “unless the filer declines the return”.

AMENDMENT NO. 2

On page 2, in line 4, strike “AT THE REQUEST OF” and substitute “UNLESS”; in line 5, strike the first comma; in the same line, strike “, ACCOMPANIED BY” and substitute “DECLINES THE RETURN, RETURN THE DOCUMENT ON PAYMENT OF”; and in line 6, strike “, RETURN THE DOCUMENT”.

On page 5, in line 1, strike “A REQUEST TO”; in the same line, after “RETURN” insert “OF”; and in line 2, strike “\$10” and substitute “\$5”.

On page 6, in lines 1 and 15, in each instance, strike “AT THE REQUEST OF” and substitute “UNLESS”; in line 2, strike the second comma; in the same line, strike “, ACCOMPANIED BY” and substitute “DECLINES THE RETURN, RETURN THE DOCUMENT ON PAYMENT OF”; in lines 3 and 17 and 18, in each instance, strike “, RETURN THE DOCUMENT”; in line 16, in each instance, strike the comma; and in line 17, strike “ACCOMPANIED BY” and substitute “DECLINES THE RETURN, RETURN THE DOCUMENT ON PAYMENT OF”.

On page 7, in lines 1 and 15, in each instance, strike “AT THE REQUEST OF” and substitute “UNLESS”; in line 2, strike the second comma; in the same line, strike “, ACCOMPANIED BY” and substitute “DECLINES THE RETURN, RETURN THE DOCUMENT ON PAYMENT OF”; in lines 3 and 17 and 18, in each instance, strike “, RETURN THE DOCUMENT”; in line 16, in each instance, strike the comma; and in line 17, strike “ACCOMPANIED BY” and substitute

“DECLINES THE RETURN, RETURN THE DOCUMENT ON PAYMENT OF”.
