1 AN ACT concerning

2 **State Police Retirement System and Law Enforcement Officers' Pension**
3 **System - Disability Retirement**

4 FOR the purpose of exempting from certain earnings limitations and certain
5 reemployment restrictions certain retirees of the State Police Retirement
6 System and Law Enforcement Officers' Pension System; and generally relating
7 to retirees of the State Police Retirement System and Law Enforcement Officers'
8 Pension System receiving disability retirement allowances.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

1 **Article - State Personnel and Pensions**

2 29-115.

3 (a) (1) This section applies only to a disability retiree who is not eligible to
4 receive a normal service retirement.5 (2) THIS SECTION DOES NOT APPLY TO A DISABILITY RETIREE OF THE
6 STATE POLICE RETIREMENT SYSTEM OR THE LAW ENFORCEMENT OFFICERS'
7 PENSION SYSTEM IF THE RETIREE:8 ~~(A) RETIRED BEFORE JULY 1, 2005; OR~~9 ~~(H) 1. RETIRED ON OR AFTER JULY 1, 2005; AND~~10 ~~2. IS REEMPLOYED BY A PARTICIPATING EMPLOYER IN ANY~~
11 ~~POSITION OTHER THAN A PROBATIONARY STATUS LAW ENFORCEMENT OFFICER, A~~
12 ~~LAW ENFORCEMENT OFFICER, OR CHIEF, AS DEFINED IN § 3-101 OF THE PUBLIC~~
13 ~~SAFETY ARTICLE.~~14 (b) (1) (i) [The] EXCEPT AS PROVIDED IN SUBSECTION (A)(2) OF THIS
15 SECTION, THE Board of Trustees shall, after giving notice, temporarily suspend the
16 retiree's allowance if the retiree:17 1. began receiving a disability retirement allowance on or
18 after July 1, 1998; and19 2. is employed by a participating employer at an annual
20 compensation that is at least equal to the retiree's average final compensation at
21 retirement.22 (ii) A temporary suspension under this subsection shall begin as of
23 the date the retiree is reemployed by a participating employer under subparagraph
24 (i)2 of this paragraph.25 (2) A retiree whose allowance is temporarily suspended under this
26 subsection is not subject to a reduction as provided in § 29-116 of this subtitle during
27 the period of employment by a participating employer.28 (3) Upon receiving satisfactory documentation that the retiree is no
29 longer employed by a participating employer, the Board of Trustees shall reinstate the
30 retiree's allowance with accumulated cost-of-living adjustments from the date the
31 allowance was temporarily suspended.32 (4) The retiree's allowance will be reinstated on the first day of the
33 month following the month in which the retiree ceased employment with the
34 participating employer.

1 (c) A member who retires on or after July 1, 1982, and receives a disability
 2 retirement allowance shall provide yearly medical and earnings information on
 3 request of the Board of Trustees until the retiree attains normal retirement age.

4 (d) If the retiree refuses to provide the information, the Board of Trustees
 5 shall suspend the retiree's allowance until the information is provided.

7 (A) THIS SECTION DOES NOT APPLY TO A RETIREE OF THE STATE POLICE
 8 RETIREMENT SYSTEM OR THE LAW ENFORCEMENT OFFICERS' PENSION SYSTEM
 9 WHO IS RECEIVING AN ORDINARY DISABILITY RETIREMENT ALLOWANCE IF THE
 10 RETIREE:

11 ~~(1) RETIRED BEFORE JULY 1, 2005; OR~~

12 ~~(2) (1) RETIRED ON OR AFTER JULY 1, 2005; AND~~

13 ~~(4)~~ IS REEMPLOYED IN ANY POSITION OTHER THAN A
 14 PROBATIONARY STATUS LAW ENFORCEMENT OFFICER, A LAW ENFORCEMENT
 15 OFFICER, OR CHIEF, AS DEFINED IN § 3-101 OF THE PUBLIC SAFETY ARTICLE.

16 [(a)] (B) [The] EXCEPT AS PROVIDED IN SUBSECTION (A) OF THIS SECTION,
 17 THE Board of Trustees shall reduce the pension of a retiree on ordinary disability if:

18 (1) the retiree is under normal retirement age;

19 (2) the medical board certifies in a report to the Board of Trustees that
 20 the retiree is engaged in a gainful occupation paying more than the difference
 21 between:

22 (i) the retiree's retirement allowance at retirement; and

23 (ii) the retiree's average final compensation plus \$5,000;

24 (3) the Board of Trustees agrees with the medical board's report; and

25 (4) the retiree's allowance has not been temporarily suspended as
 26 provided in § 29-115 of this subtitle.

27 [(b)] (C) The Board of Trustees shall reduce the pension of a retiree who has
 28 been receiving an ordinary disability retirement allowance for:

29 (1) less than 10 years, by \$1 for every \$2 that the retiree's current
 30 compensation exceeds the limit under subsection [(a)] (B) of this section; or

31 (2) at least 10 years, by \$1 for every \$5 that the retiree's current
 32 compensation exceeds the limit under subsection [(a)] (B) of this section.

33 [(c)] (D) The pension to be reduced under this section is the pension at
 34 retirement without any cost-of-living adjustment.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 July 1, 2005.
