#### **Common Sense Food Consumption Act**

3 FOR the purpose of prohibiting a person from bringing a civil action against a seller

4 of food for damages or injunctive relief based on a claim of injury or death

# 21 (2) A SUBSTANCE THAT IS USED AS A COMPONENT OF FOOD OR DRINK 22 FOR HUMAN BEINGS OR OTHER ANIMALS; OR

23 (3) CHEWING GUM.

(B) A PERSON MAY NOT BRING A CIVIL ACTION AGAINST A SELLER OF FOOD
 FOR DAMAGES OR INJUNCTIVE RELIEF BASED ON A CLAIM OF INJURY OR DEATH

6 ADVERTISEMENT, LABELING, OR SALE OF THE FOOD, AND THE VIOLATION WAS A
7 PROXIMATE CAUSE OF THE INJURY OR DEATH RESULTING FROM WEIGHT GAIN,
8 OBESITY, OR A HEALTH CONDITION RELATED TO WEIGHT GAIN OR OBESITY;

9 (2) FOR BREACH OF CONTRACT OR EXPRESS WARRANTY IN 10 CONNECTION WITH THE PURCHASE OF FOOD; OR

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be
construed to apply only prospectively and may not be applied or interpreted to have
any effect on or application to any cause of action arising before the effective date of
this Act.

16 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 17 October 1, 2005.
