AN AGENCY IN THE EXECUTIVE BRANCH OF STATE GOVERNMENT 17 (C) (1) 18 MAY USE FUNDS APPROPRIATED FOR THE PROGRAM TO: INSTALL AND MAINTAIN TELEPHONE LINES AND 20 TELECOMMUNICATIONS EQUIPMENT AT THE PRIVATE RESIDENCE OF AN EMPLOYEE 21 WHO HAS BEEN AUTHORIZED TO TELEWORK BY THE AGENCY OR AT AN ALTERNATE 22 WORK SITE THAT HAS BEEN APPROVED BY THE AGENCY; AND PAY FOR TELECOMMUNICATIONS SERVICES, SUCH AS A 23 (II)24 MONTHLY FEE FOR CONNECTION TO THE INTERNET, THAT ARE NECESSARY FOR AN 25 EMPLOYEE WHO HAS BEEN AUTHORIZED TO TELEWORK BY THE AGENCY. BEFORE AN AGENCY MAY EXPEND FUNDS UNDER PARAGRAPH (1) OF 27 THIS SUBSECTION, THE HEAD OF THE AGENCY MUST CERTIFY TO THE DEPARTMENT 28 THAT THE EXPENDITURE: 29 MEETS PROGRAM REGULATIONS AND GUIDELINES AND THAT (I) 30 THE AGENCY HAS INSTALLED ADEQUATE SAFEGUARDS TO PREVENT ABUSE; AND 31 (II)IN THE CASE OF TELECOMMUNICATIONS SERVICES, COVERS 32 ONLY THE AMOUNT OF TIME THAT AN EMPLOYEE USED THE SERVICE FOR 33 TELEWORKING PURPOSES.
