AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 28 35 of the Maryland Constitution, this Act may not be construed to extend or apply to 29 the salary or compensation of the Sheriff of Kent County in office on the effective date 30 of this Act, but the provisions of this Act concerning the salary or compensation of the 31 Sheriff of Kent County shall take effect at the beginning of the next following term of 32 office.
