- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:

- 18 (GG) IN ACCORDANCE WITH THE PROVISIONS OF SUBSECTION (A) OF THIS
- 19 SECTION, THAT PROPERTY IN GARRETT COUNTY CONTAINING APPROXIMATELY 3,000
- 20 250 ACRES AND KNOWN AS THE "CRABTREE WILDLAND PROPOSAL" IS A TYPE 1 STATE
- 21 WILDLAND AND SHALL BE NAMED THE "CRABTREE CREEK WILDLAND".

- SECTION 2. AND BE IT FURTHER ENACTED, That, in accordance with §
- 2 5-1203(gg) of the Natural Resources Article as enacted by this Act, the Department of
- 3 Natural Resources shall conduct a survey and establish a metes and bounds
- 4 description of the lands of the State, now owned or hereafter acquired, constituting
- 5 the Crabtree Creek Wildland. The Department shall submit to the Senate Education,
- 6 Health, and Environmental Affairs Committee and the House Environmental Matters
- 7 Committee a report, on or before December 1, 2005, in accordance with § 2-1246 of
- 8 the State Government Article, that includes the information necessary for the
- 9 General Assembly to enact legislation in the 2006 session that establishes the
- 10 statutory metes and bounds description of the Crabtree Creek Wildland.
- 11 SECTION 3. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall
- 12 take effect June 1, 2006.
- 13 SECTION 4. AND BE IT FURTHER ENACTED, That except as provided in
- 14 Section 3 of this Act, this Act shall take effect June 1, 2005.
