A BILL ENTITLED

1 AN ACT concerning

2 **Developmental Disabilities Administration - Prioritization System for**
3 **Investigations**

4 FOR the purpose of requiring the Developmental Disabilities Administration, in
5 conjunction with the Office of Health Care Quality, to adopt regulations
6 establishing a certain prioritization system for responding to and investigating
7 certain incidents; requiring the Administration to seek input from certain
8 individuals in developing the regulations; and generally relating to a
9 prioritization system for investigations of licensees of the Developmental
10 Disabilities Administration.

11 BY repealing and reenacting, with amendments,

14 Annotated Code of Maryland

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article - Health - General**

19 7-909.

20 (a) In this section, the word "licensee" means a person who is licensed by the
21 Administration under this title to provide services.

22 (b) The Administration or its agent shall inspect each site or office operated by
23 a licensee at least once annually and at any other time that the Administration
24 considers necessary.

25 (c) The Administration shall keep a report of each inspection.

26 (d) The Administration shall bring any deficiencies to the attention of:

27 (1) The executive officer of the licensee; or

1 (2) In the case of an intermediate care facility-mental retardation, the
2 State Planning Council and the State-designated protection and advocacy agency.

3 (E) (1) THE ADMINISTRATION, IN CONJUNCTION WITH THE OFFICE OF
4 HEALTH CARE QUALITY, SHALL ADOPT REGULATIONS THAT ESTABLISH A SYSTEM OF
5 PRIORITIZATION TO RESPOND TO AND INVESTIGATE SERIOUS REPORTABLE
6 INCIDENTS, AS DEFINED BY THE ADMINISTRATION, IN THE AREAS OF ABUSE,
7 NEGLECT, SERIOUS INJURY, AND MEDICATION ERRORS THAT THREATEN THE
8 HEALTH, SAFETY, AND WELL-BEING OF INDIVIDUALS RECEIVING SERVICES FUNDED
9 BY THE ADMINISTRATION IN STATE-OPERATED AND COMMUNITY PROGRAMS
10 LICENSED BY THE ADMINISTRATION.

11 (2) THE ADMINISTRATION SHALL SEEK INPUT FROM INDIVIDUALS WITH
12 DISABILITIES AND THEIR FAMILIES, LICENSEES, AND ADVOCACY ORGANIZATIONS IN
13 DEVELOPING THE REGULATIONS, PRIOR TO PUBLISHING THE REGULATIONS IN THE
14 MARYLAND REGISTER FOR PUBLIC COMMENT.

15 (3) THE REGULATIONS SHALL DEFINE AND ADDRESS:

16 (I) THE SYSTEM OF PRIORITIZATION FOR INVESTIGATION OF
17 SERIOUS REPORTABLE INCIDENTS AND DEATHS;

18 (II) THE SPECIFIC ROLES AND RESPONSIBILITIES OF EACH
19 GOVERNMENTAL UNIT INVOLVED IN INVESTIGATING LICENSEES;

20 (III) METHODS OF INVESTIGATIONS, INCLUDING ON-SITE
21 INVESTIGATIONS;

22 (IV) TIME LINES FOR RESPONSE TO SERIOUS REPORTABLE
23 INCIDENTS AND DEATHS AND INVESTIGATION OF SERIOUS REPORTABLE INCIDENTS
24 AND DEATHS;

25 (V) TIME LINES FOR ISSUING SPECIFIED REPORTS, INCLUDING
26 CORRECTIVE ACTION PLANS, TO THE ADMINISTRATION, LICENSEE, MORTALITY
27 REVIEW COMMITTEE, MEDICAID FRAUD UNIT, INDIVIDUALS RECEIVING SERVICES
28 FROM THE LICENSEE INVOLVED IN THE INCIDENT AND THEIR GUARDIANS OR
29 FAMILY MEMBERS, AND OTHERS;

30 (VI) FOLLOW-UP MONITORING REQUIREMENTS AND TIME LINES
31 FOR THE OFFICE OF HEALTH CARE QUALITY AND THE ADMINISTRATION TO ENSURE
32 THAT CORRECTIVE ACTION HAS BEEN IMPLEMENTED BY THE LICENSEE; AND

33 (VII) FOLLOW-UP MONITORING METHODS IN THE CASE OF A
34 STATE-OPERATED OR COMMUNITY LICENSEE THAT HAS NO DOCUMENTED SERIOUS
35 REPORTABLE INCIDENTS OF ABUSE OR NEGLECT WITHIN A CERTAIN PERIOD OF
36 TIME.

37 (4) THE FOLLOW-UP MONITORING MAY INCLUDE AN ON-SITE REVIEW
38 TO DETERMINE THAT THERE ARE NO SERIOUS REPORTABLE INCIDENTS OF ABUSE
39 AND NEGLECT, MODIFIED SURVEY SCHEDULES FOR LICENSEES DEMONSTRATING

1 CERTAIN QUALITY STANDARDS OF COMPLIANCE, AND OTHER MEASURES TO ENSURE
2 THE HEALTH, SAFETY, AND WELL-BEING OF INDIVIDUALS.

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
4 July 1, 2005.
