13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

	SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary or compensation of the Sheriff of Baltimore City in office on the effective

8 the salary or compensation of the Sheriff of Baltimore City in office on the effective9 date of this Act, but the provisions of this Act concerning the salary or compensation10 of the Sheriff of Baltimore City shall take effect at the beginning of the next following11 term of office.
