CHAPTER _____

1 AN ACT concerning

2 **Baltimore City - Sheriff - Salary and Expense Allowance**

3 FOR the purpose of altering the expense allowance amount received by the Sheriff of
 4 Baltimore City; altering the salary of the Sheriff of Baltimore City; providing
 5 that this Act does not apply to the salary or compensation of the incumbent
 6 Sheriff of Baltimore City; and generally relating to the salary and expense
 7 allowance received by the Sheriff of Baltimore City.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article - Courts and Judicial Proceedings**

16 2-309.

17 (d) (1) (i) In Baltimore City, the Sheriff shall receive an expense
 18 allowance of [\$1,000] \$750 TWO TIMES per year and a salary of:

19 1. [\$70,000] \$79,300 in calendar year [2002] 2007;

20 2. [\$70,000] \$84,600 in calendar year [2003] 2008;

- 1 3. [\$72,000] \$89,900 in calendar year [2004] 2009;
- 2 4. [\$72,000] \$95,200 in calendar year [2005] 2010; and
- 3 5. [\$74,000 in] IN calendar year [2006] 2011 and thereafter,
4 NO LESS THAN THE SALARY OF A COMMAND STAFF 2 IN THE BALTIMORE CITY
5 POLICE DEPARTMENT AT THE MIDPOINT IN THE PAY SCALE.

6 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §
7 35 of the Maryland Constitution, this Act may not be construed to extend or apply to
8 the salary or compensation of the Sheriff of Baltimore City in office on the effective
9 date of this Act, but the provisions of this Act concerning the salary or compensation
10 of the Sheriff of Baltimore City shall take effect at the beginning of the next following
11 term of office.

12 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
13 October 1, 2005.
