Harford County Sheriff - Salary

3 FOR the purpose of increasing the annual salary of the Sheriff of Harford County by
 4 certain amounts as of certain dates; providing for the calculation of the annual
 5 salary of the Sheriff on and after a certain date; establishing a limit on the
 6 annual salary increase under certain circumstances; providing that this Act does
 7 not apply to the salary of the incumbent sheriff; and generally relating to the
 8 salary of the Sheriff of Harford County.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article - Courts and Judicial Proceedings**

17 2-309.

18 (n) (1) The Sheriff of Harford County shall receive a salary of:

19 (i) [\$70,000 beginning December 1, 1998;

20 (ii) \$72,000 in 2000;

1 (iii) \$74,000 in 2001;

2 (iv) \$76,000 in 2002;

3 (v) \$84,000 in 2003; and

4 (vi)] \$90,000 in 2004 [and thereafter];

5 (II) \$98,500 COMMENCING ~~IN 2006~~ JANUARY 1, 2007, THEREAFTER
6 TO BE ADJUSTED ANNUALLY ON JULY 1 IN ACCORDANCE WITH SUBPARAGRAPH (III)
7 OF THIS PARAGRAPH.

8 (III) 1. ON AND AFTER JULY 1, ~~2006~~ 2007, THE ANNUAL SALARY OF
9 THE SHERIFF OF HARFORD COUNTY SHALL BE ADJUSTED ANNUALLY TO REFLECT
10 THE ANNUAL CHANGE IN THE "CONSUMER PRICE INDEX" FOR "ALL URBAN
11 CONSUMERS" FOR THE EXPENDITURE CATEGORY "ALL ITEMS NOT SEASONALLY
12 ADJUSTED", AND FOR ALL REGIONS; THE ANNUAL CONSUMER PRICE INDEX FOR THE
13 PERIOD ENDING EACH DECEMBER, AS PUBLISHED BY THE BUREAU OF LABOR
14 STATISTICS OF THE U.S. DEPARTMENT OF LABOR, SHALL BE USED TO ADJUST THE
15 ANNUAL SALARY OF THE SHERIFF OF HARFORD COUNTY WHILE IN OFFICE.

16 2. NOTWITHSTANDING ~~ITEM~~ SUBSUBPARAGRAPH 1 OF THIS
17 SUBPARAGRAPH, THE ADJUSTMENT TO THE ANNUAL SALARY OF THE SHERIFF OF
18 HARFORD COUNTY MAY NOT EXCEED 3 PERCENT IN ANY FISCAL YEAR.

19 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §
20 35 of the Maryland Constitution, this Act may not be construed to extend or apply to
21 the salary or compensation of the Sheriff of Harford County in office on the effective
22 date of this Act, but the provisions of this Act concerning the salary or compensation
23 of the Sheriff of Harford County shall take effect at the beginning of the next
24 following term of office.

25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2005.
