AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 20 35 of the Maryland Constitution, this Act may not be construed to extend or apply to 21 the salary or compensation of the Sheriff of Harford County in office on the effective 22 date of this Act, but the provisions of this Act concerning the salary or compensation 23 of the Sheriff of Harford County shall take effect at the beginning of the next 24 following term of office.
