Authorizing the creation of a State debt, the proceeds to serve as a grant to the Board of Directors of the Girl Scout Council of the Nation's Capital, Inc. for the planning and construction of two troop lodges, four glen shelter units, and associated roadway improvements, located in Brookville.		
7. Matching Fund Requirements		
Prior to the payment of any funds, the grantee shall provide and expend a matching fund. No part of the fund may consist of real property, in kind contributions, or funds expended prior to the effective date of this Act.

9. Description and Purpose of Grantee Organization		
Girl Scouts is the world's preeminent organization dedicated solely to girls. Working together with committed adults, we help girls grow strong in body, mind, and spirit through education and service programs for girls ages 5 to 17. With the support of more than 8,500 adult volunteers, Girl Scouts of the Nation's Capital serves over 18,000 girls in Calvert, Charles, Montgomery, Prince George's, and St. Mary's counties.		
10. Description and Purpose of Project		
Brighton Woods is adjacent to the Patuxent River just below Brighton Dam and the Tridelphia Lake Reservoir near the northeastern border of Montgomery County. Brighton Woods is used for Girl Scout troop camping, adult volunteer training courses and summer day camps and will serve the same purposes after capital improvements. It will be expanded, with two new lodges, a glen shelter, and the necessary road work, to better accommodate troops and year-round usage. Its capacity will increase from 164 to 248 campers at a time.
