FISCAL AND POLICY NOTE

House Bill 546
Economic Matters

(Delegates Cardin and Morhaim)

Cigarette Licenses - Fees and Disciplinary Authority

This bill increases the following license fees: cigarette manufacturer from \$25 to \$30; cigarette retailer from \$30 to \$35; a cigarette storage warehouse from \$25 to \$30; and the additional renewal license fee applicable to most types of licenses from \$30 to \$35. The Comptroller may deny, suspend, or revoke a license or reprimand a licensee if the individual is liable for or convicted of selling tobacco to minors.

Fiscal Summary

State Effect: General fund revenue increase of approximately \$39,400 in FY 2006. Future year increases reflect an increase in the number of manufacturers and retailer licenses issued. Any increase in hearings as a result of the new disciplinary authority could be handled with existing resources.

Local Effect: None.

Small Business Effect: Minimal.

Analysis

Current Law: The license fee for a cigarette manufacturer is \$25. A cigarette retailer license is \$30. The license fee for a cigarette storage warehouse is \$25. The additional renewal fee applicable to most types of licenses is \$30.

The Comptroller can deny, suspend, revoke a license or deny an application for a license for:

- fraudulently or deceptively obtaining or attempting to obtain a license for another person;
- fraudulently or deceptively using a license;
- failing to comply with the Maryland Cigarette Sales Below Cost Act;
- violation of cigarette sales of less than 20 per package;
- illegally buying cigarettes for resale;
- conviction of a felony or misdemeanor that is a crime of moral turpitude directly related to the fitness or qualification of the licensee or applicant; or
- failing to pay a tax due.

Background: The Comptroller of Maryland issues several types of cigarette licenses: manufacturers, wholesalers, subwholesalers, vendors, and storage warehouses. The Clerks of the Court issue cigarette retailer licenses.

State Fiscal Effect: General fund revenues are expected to increase by \$39,400 in fiscal 2006 from the fee increases. **Exhibit 1** illustrates the estimated revenue generated from these licenses under current law and under the bill.

For future years, it is estimated that there would be limited growth in new manufacturer's licenses and other licenses subject to the additional renewal fee. The number of retailer licenses is estimated to increase by 1% annually.

Any increase in hearings by the Comptroller's Office resulting from disciplinary action for applicants or licensees that sell cigarettes to minors could be handled with existing resources. The Comptroller's Office asserts that, if there is a large increase in the number of hearings, it would need to hire a full-time hearing officer. The number of additional hearings resulting from the bill cannot be reliably estimated at this time, but it is assumed to be minimal.

Prior Introductions: HB 886 of 2003, a similar bill, received an unfavorable report from the Economic Matters Committee.
