FISCAL AND POLICY NOTE

House Bill 1238 Ways and Means (Delegate Cardin, et al.)

Education - Audiologists and Speech-Language Pathologists - Licensing Fee Reimbursement

This bill requires the State to reimburse audiologists and speech-language pathologists for licensing fees if they: (1) provide audiology and speech-language services on a third-party basis in schools; and (2) are licensed by the State Board of Audiologists, Hearing Aid Dispensers, and Speech-Language Pathologists. An audiologist or speech-language pathologist must reimburse the State for the full amount received if all of the requirements for renewal of a license are not completed or services are not provided to schools on a third-party billing basis. The State Board of Education must adopt regulations to implement and administer the program.

The bill takes effect July 1, 2005.

Fiscal Summary

State Effect: General fund expenditures would increase by an estimated \$259,600 in FY 2006 to pay licensing fees for audiologists and speech-language pathologists and provide for the administration of the program. Future year expenditure estimates reflect a stable number of initial license fee reimbursements each year, the biennial license renewal cycle, and annualization and inflation in the administrative costs. Revenues would not be affected.

Local Effect: Local school expenditures could decrease minimally in school systems that currently pay the licensing fees for audiologists and speech-language pathologists.

Small Business Effect: Minimal.

Analysis

Current Law: The license application fee for an audiologist or speech-language pathologist is \$150, and the biennial renewal fee is \$252. Licenses are renewed in even-numbered years.

Background: Chapter 194 of 2003 established the Task Force to Study the Availability of Audiology and Speech-language Services. The task force released its findings and recommendations on December 31, 2003. One of the task force recommendations is to include audiologists and speech-language pathologists in legislation addressing recruitment and retention efforts in schools.

The Maryland State Teachers Association (MSTA) advises that many audiologists and speech-language pathologists working in schools have national rather than State certification. MSTA further advises that a recent regulatory adjustment to Medicaid requires service providers to hold State licensure to qualify for federal Medicaid reimbursement. As a result, more audiologists and speech-language pathologists are now pursuing State licenses at a cost of \$150 for the initial license and \$252 for each license renewal.

State Expenditures: General fund expenditures would increase by an estimated \$259,600 in fiscal 2006. This estimate reflects the costs of reimbursing audiologists and speech-language pathologists for license fees and hiring one quarter-time specialist at the Maryland State Department of Education to administer the new program. It includes the license fee reimbursements, a quarter-time salary, fringe benefits, one-time start-up costs, and ongoing operating expenses. The following information and assumptions were used in calculating the estimate.

- In fiscal 2004, approximately 150 audiologists and speech-language pathologists paid the \$150 license application fee. Assuming this number is relatively stable, reimbursements for the initial license fee would cost approximately \$22,500 in fiscal 2006.
- In fiscal 2004, approximately 900 audiologists and speech-language pathologists renewed their licenses at a cost of \$252 each. There is a biennial renewal cycle for HB 1238 / Page 2

the licenses, with fees paid in even-numbered fiscal years. Assuming the number of audiologists and speech-language pathologists remains relatively stable, reimbursements for license renewals would total \$226,800 in fiscal 2006.

Future year expenditures reflect: (1) an estimated \$22,500 annually for application fee reimbursements; (2) an estimated \$226,800 in even-numbered fiscal years for license renewal fee reimbursements; (3) 4.6% annual increases and 3% employee turnover; and (4) 1% annual increases in ongoing operating expenses.

Local Expenditures: MSTA advises that several local school systems currently reimburse audiologists and speech-language pathologists who work in schools for the cost of licenses. If the State pays the reimbursements, school expenditures in the local school systems that pay these costs would decrease.
