AMENDMENTS TO SENATE BILL NO. 144, AS AMENDED
(First Reading File Bill)

AMENDMENT NO. 1

On page 2 of the Education, Health, and Environmental Affairs Committee Amendments (SB0144/014638/1), in Amendment No. 1, strike beginning with “prohibiting” in line 1 down through “research;” in line 2; and in line 3, strike “certain material”.

On pages 1 and 2 of the bill, strike beginning with “requiring” in line 33 on page 1 down through “donations;” in line 2 on page 2.

On page 2 of the bill, strike beginning with “prohibiting” in line 4 down through “consideration;” in line 5.

AMENDMENT NO. 2

On page 3 of the Education, Health, and Environmental Affairs Committee Amendments, in line 2 of Amendment No. 3, strike “(J)” and “(K)”, respectively, and substitute “(I)” and “(J)”, respectively; in line 3, strike “(I) “OOCYTE” MEANS A FEMALE GERM CELL OR EGG.”; strike beginning with the colon in line 5 down through “(2)” in line 8; in line 9, strike “INDEFINITELY”; in line 10, strike “MANY OTHER TYPES”; in the same line, strike “(L)”; and in line 11, strike “IN CONNECTION WITH MATERIAL OBTAINED IN”.

On page 4 of the Education, Health, and Environmental Affairs Committee Amendments, in the first line of Amendment No. 3, strike “ACCORDANCE WITH § 5-2B-10 OF THIS SUBTITLE”.

On page 4 of the bill, strike in their entirety lines 16 and 17.

AMENDMENT NO. 3

On page 8 of the Education, Health, and Environmental Affairs Committee Amendments, in

line 3 of Amendment No. 7, strike "5-2B-10.".

On page 9 of the Education, Health, and Environmental Affairs Committee Amendments, in lines 12 and 13 and 14 of Amendment No. 7, in each instance, strike "ANY UNUSED MATERIAL"; and strike beginning with "EXCEPT" down through "SECTION,".

On page 9 of the Education, Health, and Environmental Affairs Committee Amendments, in line 2 of Amendment No. 8, strike "ANY UNUSED MATERIAL"; strike beginning with "(B)" in line 3 down through "OOCYTE." in line 4; in line 5, strike "(C)"; in line 6, strike "5-2B-11." and substitute "5-2B-10."; in the same line, strike "5-2B-12."; in the same line, strike "5-2B-13" and substitute "5-2B-11"; and strike beginning with "ANY" in line 7 down through "SUBTITLE" in line 8.

On page 10 of the Education, Health, and Environmental Affairs Committee Amendments, in line 2 of Amendment No. 8, strike "MATERIAL DONATED IN ACCORDANCE WITH § 5-2b-10 OF THIS SUBTITLE".

On pages 9 and 10 of the bill, strike in their entirety the lines beginning with line 24 on page 9 through line 5 on page 10.

On page 2 of the bill, strike in their entirety lines 10 through 18, inclusive.
