- 3 (a) The State's Attorneys in the several counties of the State shall receive 4 annually the respective salaries set forth for performing the duties required of them
- 5 by their respective public local laws and by the public general laws, and such
- 6 expenses as are provided by law and by the current practice in the several counties.
- 7 The State's Attorneys shall receive annual payments for office, traveling and other
- 8 expenses. All payments for salaries and expenses shall be made by the respective
- 9 counties in equal monthly installments unless otherwise specified. The salaries and
- 10 expenses are as follows:
- 11 (i) In Charles County, the State's Attorney's salary shall be [90% of the
- 12 salary of a judge of the District Court of Maryland] EQUAL TO THE SALARY OF A
- 13 JUDGE OF A CIRCUIT COURT IN THE STATE. In addition to the compensation provided
- 14 for in this section, the State's Attorney shall be entitled to reimbursement for
- 15 reasonable expenses during his performance of duties, subject to the approval of the

- 18 appear as counsel or represent any party professionally before any court, board,
