## CHAPTER\_\_\_\_\_

1 AN ACT concerning

2 **Calvert County - County Officials - Salaries**

3 FOR the purpose of altering the salaries of the County Commissioners of Calvert  
4 County, Calvert County Treasurer, Sheriff of Calvert County, and Orphans'  
5 Court Judges for Calvert County; providing that this Act does not apply to the  
6 salary or compensation of the incumbent County Commissioners of Calvert  
7 County, Calvert County Treasurer, Sheriff of Calvert County, or Orphans' Court  
8 Judges for Calvert County; and generally relating to the salaries of certain  
9 Calvert County officials.

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
9 MARYLAND, That the Laws of Maryland read as follows:

10 **Article 5 - Calvert County**

11 2-101.

12 (a) Five county commissioners comprise the Board of County Commissioners  
13 of Calvert County.

14 (b) (1) The annual salary of the president of the board is:

15 (I) [\$37,500] \$41,500 for calendar year [2002] 2006;

16 (II) [\$38,500] \$42,500 for calendar year [2003] 2007;

17 (III) [\$39,500] \$43,500 for calendar year [2004] 2008; and

18 (IV) [\$40,500] \$44,500 for calendar year [2005] 2009 and each  
19 subsequent calendar year.

20 (2) The annual salary of each of the associate members of the board is:

21 (I) [\$35,000] \$39,000 for calendar year [2002] 2006;

22 (II) [\$36,000] \$40,000 for calendar year [2003] 2007;

23 (III) [\$37,000] \$41,000 for calendar year [2004] 2008; and

24 (IV) [\$38,000] \$42,000 for calendar year [2005] 2009 and each  
25 subsequent calendar year.

26 (c) Each commissioner may be reimbursed up to an annual total of \$2,000, for  
27 any reasonable costs incurred by the commissioner in carrying out the functions of the  
28 office.

29 **Article 25 - County Commissioners**

1 (c) (1) The County Treasurer of Calvert County shall receive an annual  
2 salary of:

- 3 (i) [\$44,000] \$46,875 for calendar year [2002] 2006;
- 4 (ii) [\$44,500] \$48,250 for calendar year [2003] 2007;
- 5 (iii) [\$45,000] \$49,625 for calendar year [2004] 2008; and
- 6 (iv) [\$45,500] \$51,000 for calendar year [2005] 2009 and each  
7 subsequent calendar year.

8 **Article - Courts and Judicial Proceedings**

9 2-309.

10 (f) (1) The Sheriff of Calvert County shall receive an annual salary of:

- 11 (i) [\$57,000] \$67,500 for calendar year [2002] 2006;
- 12 (ii) [\$59,500] \$68,500 for calendar year [2003] 2007;
- 13 (iii) [\$62,000] \$69,500 for calendar year [2004] 2008; and
- 14 (iv) [\$64,500] \$70,500 for calendar year [2005] 2009 and each  
15 subsequent calendar year.

16 **Article - Estates and Trusts**

17 2-108.

18 (f) (1) Each of the judges of the Court for Calvert County shall receive as  
19 annual compensation the sum of:

- 20 (i) [\$7,000] \$8,000 for calendar year [2002] 2006;
- 21 (ii) [\$7,250] \$8,250 for calendar year [2003] 2007;
- 22 (iii) [\$7,500] \$8,500 for calendar year [2004] 2008; and
- 23 (iv) [\$7,750] \$8,750 for calendar year [2005] 2009 and each  
24 subsequent calendar year.

25 (2) The salary of the Chief Judge is:

- 26 (i) [\$7,200] \$8,200 for calendar year [2002] 2006;
- 27 (ii) [\$7,450] \$8,450 for calendar year [2003] 2007;
- 28 (iii) [\$7,700] \$8,700 for calendar year [2004] 2008; and

1 (iv) [\$7,950] \$8,950 for calendar year [2005] 2009 and each  
2 subsequent calendar year.

3 (3) The County Commissioners may provide additional funds for  
4 expenses for the judges.

5 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §  
6 35 of the Maryland Constitution, this Act may not be construed to extend or apply to  
7 the salary or compensation of the County Commissioners of Calvert County, Calvert  
8 County Treasurer, Sheriff of Calvert County, or Orphans' Court Judges for Calvert  
9 County in office on the effective date of this Act, but the provisions of this Act  
10 concerning the salary or compensation of the County Commissioners of Calvert  
11 County, Calvert County Treasurer, Sheriff of Calvert County, or Orphans' Court  
12 Judges for Calvert County shall take effect at the beginning of the next following term  
13 of office.

14 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
15 October 1, 2006.
