A BILL ENTITLED

1 AN ACT concerning

2 **Primary and Secondary Education - Aging Schools Program - Grants**

3 FOR the purpose of requiring the State to distribute a certain amount of money
4 allocated to the Aging Schools Program as grants to county boards of education
5 according to a certain formula in certain fiscal years; requiring the Interagency
6 Committee on School Construction to allocate a certain percentage of the
7 appropriation for public school construction to the Aging Schools Program in
8 certain fiscal years; providing for the termination of this Act; and generally
9 relating to grants and the Aging Schools Program.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

26 (K) IN ADDITION TO THE GRANTS REQUIRED UNDER § 5-206(F)(1) OF THIS
27 TITLE, IN FISCAL YEARS 2008 THROUGH 2018, THE INTERAGENCY COMMITTEE SHALL

1 ALLOCATE 15% OF THE AMOUNT APPROPRIATED FOR PUBLIC SCHOOL
2 CONSTRUCTION TO THE AGING SCHOOLS PROGRAM.

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
4 July 1, 2006. It shall remain effective for a period of 12 years and, at the end of June
5 30, 2018, with no further action required by the General Assembly, this Act shall be
6 abrogated and of no further force and effect.
