FISCAL AND POLICY NOTE

House Bill 552 (Carroll County Delegation)

Environmental Matters Judicial Proceedings

Carroll County - Sheriff's Salary

This bill increases the annual salary of the Carroll County Sheriff from \$65,000 to \$71,532 beginning December 5, 2006. The bill provides for yearly salary increases until the annual salary reaches \$75,910 beginning December 8, 2009.

Fiscal Summary

State Effect: None.

Local Effect: Carroll County personnel expenditures would increase by approximately \$5,100 in FY 2007 and by \$14,700 in FY 2011. Revenues would not be affected.

Small Business Effect: None.

Analysis

Current Law: The current annual salary of the Carroll County Sheriff is \$65,000. Salary adjustments for constitutional officers take effect at the beginning of the next term of office, which for the Carroll County Sheriff is December 5, 2006.

Background: The annual salary of the Carroll County Sheriff was last changed by Chapter 623 of 2001 when it increased from \$45,000 to \$50,000 in December 2002. The Act provided an annual increase of \$5,000 until the salary reached \$65,000 in December 2005. **Exhibit 1** shows the fiscal 2005 actual salaries of sheriffs for selected Maryland counties.

Local Fiscal Effect: Carroll County personnel expenditures would increase by \$5,144 in fiscal 2007, reflecting the seven-month period of December 2006 through June 2007, and by \$14,729 in fiscal 2011 for increased compensation to the Carroll County Sheriff. This estimate assumes a constant employer contribution rate for fringe benefits of 35% as advised by the county. **Exhibit 2** shows the proposed salary amounts for the Carroll County Sheriff and **Exhibit 3** shows the corresponding increase in compensation for fiscal 2007 through 2011.
