BY repealing and reenacting, with amendments, Article – Transportation Section 13-619.1 Annotated Code of Maryland (2006 Replacement Volume and 2006 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

16 17 18 19 20 21	(E) IF, WHETHER BY ACT OF THE PARTIES OR BY OPERATION OF LAW, THE TITLE OR OWNERSHIP INTEREST IN A VEHICLE ASSIGNED A SPECIAL REGISTRATION UNDER THIS SECTION IS TRANSFERRED FROM THE JOINT NAMES OF A HUSBAND AND WIFE TO THE INDIVIDUAL NAME OF EITHER SPOUSE, THE TRANSFEREE MAY CONTINUE TO USE THE SAME SPECIAL REGISTRATION PLATES ISSUED UNDER THIS SECTION ON THE VEHICLE AFTER THE TRANSFER.
